ORDER

An order of the Chiropractic Examining Board to create Chir 5.01 (1) (a) of the administrative code relating to continuing education requirements for chiropractors, and requiring completion of education in specified areas.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5), 227.11 (2) (a) and 446.02 (1) (b), Stats.

Statutes interpreted: s. 446.02 (1) (b), Stats.

In this order, the Chiropractic Examining Board proposes to require chiropractors licensed in Wisconsin to acquire 4 hours of continuing education in each of 2 topics, boundary training and AIDS. Boundary training is intended to help chiropractors recognize and avoid interference with their patient's expectations of privacy, and teach communication where contact with intimate body parts is expected in the course of treatment so that the patient is not surprised or offended. AIDS training is intended to help chiropractors protect the public health and safety through appropriate precautions in the chiropractic office.

TEXT OF RULE

SECTION 1. Chir 5.01 (1) (a) is created to read:

Chir 5.01 (1) (a) Every chiropractor who, on January 1, 1992, possessed a license to practice chiropractic in the state shall complete one, 4 hour continuing education program in the topic of boundary training, and one, 4 hour continuing education program in the topic of preventing the transmission of human immunodeficiency virus in the chiropractic office no later than December 31, 1992. Every person who became licensed to practice chiropractic in this state after January 1, 1991, but before January 1, 1993, shall complete one, 4 hour continuing education program in boundary training and one, 4 hour continuing education program in preventing the transmission of human immunodeficiency virus in the chiropractic office no later than December 31, 1994.

(END OF TEXT OF RULE)

The rules adopted in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register pursuant to s. 227.22 (2) (intro.), Stats.
