

An order of the Veterinary Examining Board to amend VE 3.03 (3) and 8.03 (1) (c) relating to examination fees.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2), 440.03 (2), 440.05 (1) and 453.03 (1), Stats.

Statutes interpreted: ss. 440.05 (1) and 453.06 (1), Stats.

In this proposed rule-making order the Veterinary Examining Board amends ss. VE 3.03 (3) and 8.03 (1) (c) as a result of rule-making by the Department of Regulation and Licensing, Clearinghouse Rule 93-113, effective December 1, 1993. In Clearinghouse Rule 93-113, the Department of Regulation and Licensing repealed and recreated s. RL 4.04 to reflect revisions to s. 440.05 (1), Stats., contained in 1993 Wisconsin Act 16. Listing of specific fees is removed from s. RL 4.04 and replaced by a rule which requires the department to maintain and make available to the public a list of current examination fees.

SECTION 1. VE 3.03 (3) is amended to read:


