

ORDER

An order of the Medical Examining Board to amend Med 20.03 (1) (f) 1 relating to the accreditation of respiratory care programs.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2) and 448.40 (1), Stats.

Statutes interpreted: s. 448.05 (5r), Stats.

This proposed rule-making order is the result of a change made by the American Medical Association of the accreditation of respiratory care practitioner programs. The Joint Review Committee for Respiratory Therapy Education of the American Medical Association will no longer provide accreditation of these programs. It will now be the responsibility of the Commission on Accreditation of Allied Health Education Programs.


The amendment to s. Med 20.03 (1) (f) 1 is necessary to bring the rule into conformity with the current organization that will provide the accreditation.

TEXT OF RULE

SECTION 1. Med 20.03 (1) (f) 1 is amended to read:

Med 20.03 (1) (f) 1. Satisfactory evidence that the applicant is a graduate of a school with a course of instruction in respiratory care approved by the ~~joint review committee for respiratory therapy education~~ commission on accreditation of allied health education programs of the American medical association.




