ADOPTING RULES

(CLEARINGHOUSE RULE 94-112)

ORDER

An order of the Barbering and Cosmetology Examining Board to renumber BC 1.01 (1); to amend Figure 6.03 (1) and Figure 6.04 (3); and to create BC 1.01 (1) relating to the theory syllabus for instruction for apprentices and practical training for apprentices to include the topic of artificial nails.

Analysis prepared by the Department of Regulation and Licensing.

<u>ANALYSIS</u>

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2) and 440.62 (5) (b), Stats.

Statutes interpreted: ss. 440.62 (5) (b) and 454.10 (1) and (2), Stats.

In this proposed rule-making order, the Barbering and Cosmetology Examining Board amends Figures 6.03 (1) and 6.04 (3) which currently do not specify that the manicuring portion of the theory syllabus for apprentices and the practical training for apprentices include the topic of artificial nails. Because artificial nails are now a major part of the practice of manicuring, minimally competent practice requires a basis of education, training and experience in the topic. The amendment to the rules will permit the board to include the topic on the licensing examinations, and to require minimal competence in the practice as a condition of licensure.

TEXT OF RULE

SECTION 1. BC 1.01 (1) is renumbered 1.01 (1m).

SECTION 2. BC 1.01 (1) is created to read:

BC 1.01 (1) "Artificial nails" means any material other than nail polish which is added to the fingernail or toenail generated by the person's own body, or which is used to replace the fingernail or toenail of a person.

SECTION 3. Figure BC 6.03 (1) is amended to read:
