(CLEARINGHOUSE RULE 94-130)

ORDER

An order of the Nursing Home Administrator Examining Board to amend NHA 2.01 (title); to repeal and recreate NHA 4.01; and to create NHA 2.01 (3) and 2.02 (1) (d) relating to examinations and licensure requirements.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2) and 456.02 (2), Stats.

Statutes interpreted: ss. 456.03, 456.04 and 456.05, Stats.

These rules are being proposed for purposes of clarifying the application and examination requirements that an applicant must complete in order to obtain a license to practice as a nursing home administrator. Under the current rules, it is not clear that an applicant must pass a 2-part examination or that an applicant must submit an application for licensure as well as an application for examination. An applicant who fails to complete all requirements for licensure within two years after filing an application must submit a new application and satisfy additional requirements.

TEXT OF RULE

SECTION 1. NHA 2.01 (title) is amended to read:

NHA 2.01 (title) EXAMINATIONS.

SECTION 2. NHA 2.01 (3) is created to read:

NHA 2.01 (3) The examination shall consist of the following:

- (a) Part I the national examination prepared by NAB, and
- (b) Part Π the state law examination prepared by the board.

SECTION 3. NHA 2.02 (1) (d) is created to read:

NHA 2.02 (1) (d) The fees specified in s. 440.05 (1), Stats.

Note: A list of all current examination fees may be obtained at no charge from the Office of Examinations, Department of Regulation and Licensing, 1400 East Washington Avenue, P.O. Box 8935, Madison, WI 53708.

SECTION 4. NHA 4.01 is repealed and recreated to read:

NHA 4.01 LICENSURE. (1) APPLICATION. An applicant for licensure shall:

- (a) Submit an application for licensure on a form approved by the board.
- (b) Satisfy the examination requirements specified in s. NHA 2.02 (1).
- (c) Satisfy the experience requirements specified in s. NHA 2.02 (2).

Note: Application forms are available on request to the board office located at 1400 East Washington Avenue, Room 290, P.O. Box 8935, Madison, Wisconsin 53708.

- (2) REAPPLICATION. An applicant who fails to satisfy all requirements for licensure within 2 years after filing an application for licensure shall file a new application, retake the state law examination and resubmit verification of successful completion of the NAB examination.
- (3) REGISTRATION. Every person granted a license as a nursing home administrator shall be deemed registered for the current registration period. Registrants must qualify biennially for certificates of renewal.
