## PROPOSED ORDER OF THE TECHNICAL COLLEGE SYSTEM BOARD AMENDING RULES RELATING TO DISTRICT PUBLIC CONSTRUCTION COMPETITIVE BIDDING REQUIREMENTS (Clearinghouse Rule 95-031)



The Wisconsin Technical College System Board proposes an order to amend s. TCS 6.05(c) and (1) relating to competitive bidding requirements for public construction.

## ANALYSIS PREPARED BY THE TECHNICAL COLLEGE SYSTEM BOARD.

Statutory Authority: s. 227.11(2)(a), Stats.

Statute Interpreted: s. 38.18, Stats.

1993 Wisconsin Act 397 amended s. 38.18, Stats., to change the threshold at which district public construction contracts must be let to the lowest responsible bidder, from \$5,000.00 to \$10,000.

The proposed rule amendment brings ch. TCS 6, Wis. Admin. Code, into conformity with the statutory amendment. Specifically, the rule amendment amends ss. TCS 6.05(2)(c) and (1) to designate \$10,000.00 as the correct dollar threshold at which districts are required to seek competitive bids in public construction projects.

- 1 Section 1. Sections TCS 6.05(2)(c) and (1) are amended to read:
- 2 TCS 6.05 PROCUREMENT. (2)(c) Require that all procurements where the total cost exceeds \$10,000
- and public construction under par. (1) where the total cost exceeds \$5,000 \$10,000 be accomplished
- 4 through the use of competitive bids except as provided by policies and procedures adopted under pars.
- 5 (d) and (e).
- 6 (2)(1) Require that all contracts made by a district board for public construction in a district, where the
- 7 estimated cost exceeds \$5,000 \$10,000, be let by a district board to the lowest responsible bidder in
- 8 accordance with ss. 38.18 and 62.15(1) to (11) and (14), Stats.

The proposed rule amendment contained in this order shall take effect on the first day of the month commencing after the date of publication in the Wisconsin Administrative Register as provided in s. 227.22(2)(intro.), Stats.
