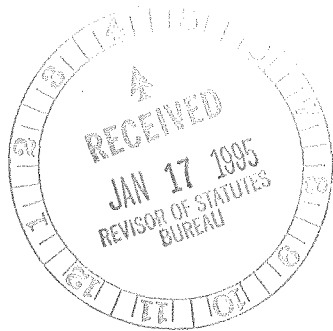

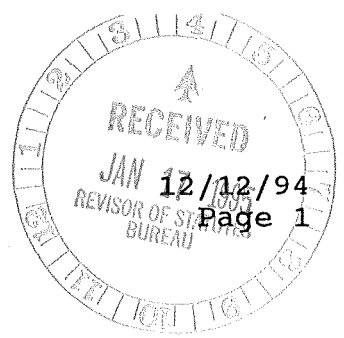

**ORDER OF THE
WISCONSIN ENVIRONMENTAL EDUCATION BOARD
ADOPTING EMERGENCY RULES**

The Wisconsin Environmental Education Board hereby amends EEB 2.03(1)(a) and (b) and EEB 2.04(3)(a)1, and creates EEB 2.04(2)(j) and (3m) and EEB 2.05, relating to environmental education board grants.

ANALYSIS BY THE WISCONSIN ENVIRONMENTAL EDUCATION BOARD

Statutory authority: ss. 115.375(2)(c) and 227.11(2)(a), Stats.

Statute interpreted: s. 115.375, Stats.

Under s. 115.375, Stats., an environmental education grant program is established and is administered by an environmental education board. Under the grant program, nonstock, nonprofit corporations and public agencies may apply for grants to develop, disseminate, and present environmental education programs.

The emergency rules allow eligible corporations or public agencies to apply for funds on behalf of a private school if specific documentation is provided. In addition, the corporation, public agency, and private school must meet specific assurances. Finally, technical amendments have been made to make the rules consistent with state statutes.

1 **SECTION 1.** EEB 2.03(1)(a) and (b) are amended to read:

2 EEB 2.03(1)(a) ~~Advise and assist~~ Consult with the state superintendent of public instruction in
3 establishing priorities for environmental education in public schools to be used in the event that the amount
4 of appropriations is insufficient to fund all applications.

5 (b) ~~Advise and assist~~ Consult with other state agencies, including the university of Wisconsin-
6 extension, conservation and environmental groups, youth organizations and nature and environmental centers
7 in identifying needs and establishing priorities for environmental education.

8 **SECTION 2.** EEB 2.04(2)(j) and (3m) are created to read:

9 EEB 2.04(2)(j) The name and address of any private school on whose behalf the corporation or public
10 agency is applying.

11 (3m) Any corporation or public agency applying on behalf of a private school shall provide all
12 documentation with respect to the private school as specified under sub. (2). That documentation shall be
13 part of the application submitted by the corporation or private agency under sub. (2).

1 SECTION 3. EEB 2.04(3)(a)1 is amended to read:

2 EEB 2.04(3)(a)1 The extent to which the application justifies the need for the project, identifies the
3 target audience, and relates it to one or more of the priority needs established annually ~~by the state~~
4 ~~superintendent as specified in~~ under s. EEB 2.03(1)(a).

5 SECTION 4. EEB 2.05 is created to read:

6 EEB 2.05 PRIVATE SCHOOL PARTICIPATION. A corporation or public agency may apply for
7 funds on behalf of a private school as specified under s. EEB 2.04(3m) if the corporation or public agency
8 and the executive officer or board of the private school agree to all of the following assurances:

9 1. Funds received under this chapter may not be used for religious activity or religious instruction.

10 2. Any materials purchased shall be nonsectarian in nature and content and may not be used for
11 religious activity or religious instruction.

12 3. Title to and administrative control of any capital goods purchased shall remain with the
13 corporation or public agency. As long as the environmental education program remains in effect and meets
14 the requirement under subd. 2, the capital goods may be located in the private school facility.

15 4. Grant funds may not be used to pay a private school instructor's salary.


FINDING OF EMERGENCY

Applications for environmental education board grants will be submitted to the environmental education board on January 27, 1995. In order for the board to review the proposals and make grant awards in time for the program to operate in the second semester, rules must be in place as soon as possible.

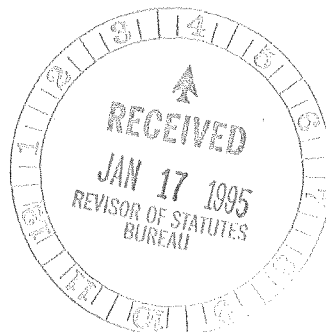
Therefore, the state superintendent finds that an emergency exists and that promulgation of emergency rules is necessary to preserve the public welfare.

The rules contained in this order shall take effect upon publication as emergency rules pursuant to the authority granted by s. 227.24, Stats.

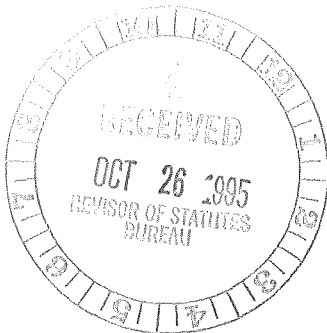



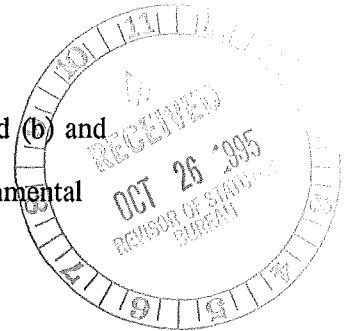
