WHEREAS, smoke-free environments prevent exposure to the thousands of chemicals and 43 known carcinogens present in tobacco smoke; and

WHEREAS, smoke-free environments promote smoke-free living and assure that our communities reflect what we teach our children in school; and

WHEREAS, smoke-free environments support the almost 80 percent of Wisconsin smokers who want to quit; and

WHEREAS, Wis. Stat. s. 101.123 (2) (a) and (4) (a) prohibit smoking in any enclosed, indoor area of a state building, unless a person in charge of his or her agency designates a smoking area, and such designation is not otherwise inconsistent with a directive of a fire marshal, law, ordinance or resolution which prohibits smoking;

NOW, THEREFORE, I, JIM DOYLE, Governor of the State of Wisconsin, by the authority vested in me by the Constitution and the laws of this State, do hereby direct cabinet secretaries to declare, in 30 days from the date of this order, that state office buildings under the control of cabinet secretaries be completely smoke-free, thereby repealing any smoking area designation under Wis. Stat. s. 101.123 (4) (a).

WHEREAS, the United States is now dependent on foreign oil imports, thereby posing a serious threat to the energy security of Wisconsin and our nation; and

WHEREAS, the major oil companies have dramatically increased the price of a tank of gas this year, driving up the cost of operating gasoline fueled vehicles; and

WHEREAS, the increased use of agricultural renewable fuels such as ethanol and biodiesel will reduce our dependence on imported oil, will reduce the vulnerability of the State of Wisconsin and Wisconsin's middle class and working families to the pricing vagaries of the major oil companies, and will create high paying and family supporting jobs in Wisconsin; and

WHEREAS, there are available in ever increasing volumes cleaner-burning, sustainable alternatives to conventional fuels that can be produced domestically; and

WHEREAS, the burning of conventional transportation fuels such as gasoline and diesel by motor vehicles contributes to air pollution, health problems and increased carbon emissions that have been linked to global climate change; and

WHEREAS, there are numerous other important economic development benefits resulting from the use of renewable fuels, including but not limited to strengthening our agricultural and forestry sectors, improving net farm income, improving our rural economies, and creating new renewable fuels industry related jobs; and

WHEREAS, there are currently at least 25 public, government and private renewable fuel refueling facilities in Wisconsin; and

WHEREAS, transportation fuel costs represent a substantial operating expense for state government and Wisconsin taxpayers; and

WHEREAS, Wisconsin state government should "lead by example" in using renewable fuels to the maximum extent feasible so as to encourage individuals, businesses and other levels of government to do the same;

NOW, THEREFORE, I, JIM DOYLE, Governor of the State of Wisconsin, by virtue of the authority vested in me by the Constitution and laws of the State of Wisconsin, do hereby:

1. Direct the Department of Administration to require, through its fleet management policy, that all state agencies reduce the use of petroleum-based gasoline in state-owned vehicles by twenty percent (20%) by 2010 and by fifty percent (50%) by 2015, and reduce the use of

petroleum-based diesel fuel by those vehicles ten percent (10%) by 2010 and twenty five percent (25%) by 2015; and

2. Direct the Department of Administration to develop an awareness plan designed to facilitate usage of renewable fuels in the State's flex fuel vehicle fleet. This program shall ensure:

- a. All flex fuel vehicles in the State's fleet shall be identifiable; and

- b. All state employees driving flex fuel vehicles shall be made aware of the renewable fuel refueling stations in the location of their destination; and

- c. All state employees shall strive to use renewable fuels when operating flex fuel and diesel powered vehicles in the fleet, whenever practical and cost effective; and

3. Direct the Secretaries of the Department of Administration and the Department of Agriculture, Trade and Consumer Protection to actively pursue the establishment of additional renewable fuel refueling facilities at public retail outlets.

WHEREAS, Wisconsin has a proud tradition of national leadership in conservation, energy and public health that provides a high quality of life for Wisconsin residents and businesses; and

WHEREAS, the State of Wisconsin owns over 6,200 facilities with a total replacement value in excess of \$9.5 billion, costing more than \$125 million dollars annually in utility costs alone to operate; and

WHEREAS, high performance green building practices can substantially cut costs of operating and maintaining state buildings over the life of the building such that a small investment in green building design yields long-term financial benefits of more than ten times the initial investment while conserving energy, water, materials and land, and improving worker health and productivity; and

WHEREAS, the adoption of high performance green building standards in new and existing buildings will help protect the health and well-being of our children, students, employees and citizens; and

WHEREAS, Wisconsin state agencies, through their practices and through public/private partnerships, can have quantifiable, positive environmental and economic impacts; and

WHEREAS, Wisconsin is dedicated to the environmental health and safety of its employees, and to efficient and effective work environments in state-owned facilities; and

WHEREAS, the State of Wisconsin enjoys a unique and timely opportunity to design, construct, and renovate buildings for the twenty-first century that will serve the needs of our citizens and employees for years to come and that will incorporate a building's life cycle and reduced operating costs; and

WHEREAS, it is in the best interests of the people of Wisconsin that all state buildings constructed, expanded, or

renovated shall be modern facilities of the twenty-first century, combining energy-efficient design, environmentally sustainable systems, and maximum access and benefit to employees and the public;

NOW, THEREFORE, I, JIM DOYLE, Governor of the State of Wisconsin by the authority vested in me by the Constitution and the Laws of this State do hereby:

1. Direct the Department of Administration, in consultation with state agencies and the UW System, to set energy efficiency goals for state facilities, office buildings or complexes, and campuses for FY07, FY08, and FY09 by July 30th 2006. The goals should reduce overall actual energy usage per square foot by at least 10% by FY08 from the FY05 state energy report baseline adjusted for weather and 20% by 2010. I further direct the Department of Administration and state agencies to use all existing statutory authority in implementing measures to achieve these energy goals; and
2. Direct the Department of Administration, in consultation with state agencies and the UW System, to establish programs for energy analysis of state-owned buildings and identify reduced energy use under section 16.858 of the Wisconsin Statutes. In addition, any state agency responsible for state-owned facilities will examine the feasibility for a performance contract for energy and operational cost savings under section 16.858 of the Wisconsin Statutes. The Department of Administration will provide centralized reporting and coordination of comprehensive capital energy improvements; and
3. Direct the Department of Administration to work with the Building Commission and the Energy Center of Wisconsin to ensure that new state facilities are constructed to be 30% more energy efficient than commercial code; and
4. Direct the Department of Administration, in consultation with state agencies and UW System, to ensure better oversight and management of energy purchasing through measures such as utility billing audits, consolidation of accounts and utility bills, and proactive elimination of unnecessary utility accounts; and
5. Direct the Department of Administration to establish sustainable building operation guidelines (for owned and leased properties), which shall be adopted by the Division of State Facilities within six (6) months following the date of this order, based on the Leadership in Energy and Environmental Design (LEED<sup>™</sup>) Green Building Rating System for New Construction and Existing Buildings and other comparable sustainable guidelines and rating systems. The State guidelines will recognize the use of wood-based materials and products from the Forest Stewardship Council (FSC), American Tree Farm System (ATFS), and Sustainable Forest Initiative (SFI) certification programs. For certification, LEED<sup>™</sup> and other comparable sustainable guidelines and rating systems may be pursued and the Department of Administration will support projects that request certification as part of the initial project request. In addition, the State will give credit for the use of wood-based products and materials from FSC, ATFS and SFI certification programs when LEED<sup>™</sup> certification is pursued. These guidelines will apply to the operations and construction of all new buildings, additions and retrofit projects, including planning, siting, budgeting, design, construction and deconstruction. In addition, these guidelines will address sustainable operation and maintenance, including green cleaning, green purchasing waste reduction and recycling, pollution prevention, energy and water efficiency, and light pollution in existing buildings. The guidelines should include identifying performance data that will be measured to assess the effectiveness of the efforts and for benchmarking purposes. Progress and Outcomes will be reported annually to the Governor's office as well as the State of Wisconsin Building Commission; and

6. Direct that the Department of Administration, at a minimum, shall ensure that on each project the following approaches are implemented; an integrated design process including high performance green goal-setting charrettes; energy modeling used as a design tool and then truthed at the phase of construction documents on buildings more than 20,000SF or Advanced Building Guidelines for those up to 80,000SF; commissioning and retrocommissioning; review at completion of Schematic Design, Design Development documents and Construction Documents that the design intent of the green goals are incorporated into the documents and are being met; minimum indoor air quality approaches to construction; and, minimal ventilation requirements for indoor environmental quality that meet the current version of ASHRAE, now ASHRAE 62.1- 2004 Ventilation for Acceptable Indoor Air Quality. Further, the Department of Administration shall provide performance information on a project-by-project basis as part of a statewide building performance database; and
7. Direct the Department of Administration to pursue demonstration projects at state facilities, including the Capitol and Executive Residence, generate electricity and use alternative fuels for heating and cooling; and
8. Direct that each state agency and the UW System assign a lead person to work with the Department of Administration in the development of the sustainability and energy efficiency goals, the budget and management review, the purchasing of renewable energy, and the implementation of the sustainable building guidelines.

WHEREAS, waterfront property owners deserve, to the greatest extent possible, certainty about their rights to place piers and wharves in the waters of the State; and

WHEREAS, the Wisconsin Legislature passed 2003 Wisconsin Act 118 which revised regulations in chapter 30 of the Wisconsin Statutes related to piers and similar structures, and I signed 2003 Wisconsin Act 118 into law on February 6, 2004; and

WHEREAS, Act 118 contemplated further action in order to create general categories of permissible pre-existing piers and wharves and permissible new piers and wharves; and

WHEREAS, my administration has successfully worked closely for more than 18 months with a broadly representative stakeholder group to develop mutually acceptable standards for permissible piers and wharves that reasonably balance the rights of waterfront property owners and of the public to access and enjoyment of the waters of the State; and

WHEREAS, the Department of Natural Resources has authority to administer the laws governing placement of piers and wharves in the waters of the State, including the ability to exercise enforcement discretion in administering those laws; and

WHEREAS, the 2006 boating season is quickly approaching;

NOW, THEREFORE, I, JIM DOYLE, Governor of the State of Wisconsin, by virtue of the authority vested in me by the Constitution and laws of the State of Wisconsin, do hereby:

1. Take this action to provide waterfront property owners certainty, to the fullest extent possible, as to their rights to place piers and wharves;
2. Direct the Department of Natural Resources to do the following:

- a. Not seek removal or modification of any pier or wharf originally placed by the waterfront property owner before February 6, 2004, provided that:
    - i. The pier or wharf does not exceed 8 feet in width;
    - ii. Does not have a wider loading platform at the waterward end of the pier that is more than 200 square feet or more than 300 square feet if it is no more than 10 feet wide;
    - iii. That the pier or wharf does not interfere with the rights of other waterfront property owners; and
    - iv. That the pier or wharf was not the subject of enforcement action initiated by the Department before February 6, 2004;
  - b. Continue to allow minor reconfigurations or relocations of any pier or wharf originally placed by the waterfront property owner before February 6, 2004, provided that the size of the pier or wharf is not increased;
  - c. Continue to recognize the terms of any existing permit or other written authorization for a pier or wharf provided that the pier or wharf is in compliance with the conditions of the permit or authorization;
  - d. Not seek removal or modification of any pier or wharf originally placed by the waterfront property owner on or after February 6, 2004, provided that:
    - i. The pier or wharf does not harm the public interest;
    - ii. The pier or wharf is no more than 6 feet wide except that a pier may have a loading platform at the waterward end that is not more than 8 feet wide and which is perpendicular to the pier; and
    - iii. The pier or wharf meets existing length and boat slip density standards;
  - e. Continue to implement the terms of s. NR 326.04 (1) with respect to pier length by allowing piers to extend the greater of the three foot depth contour or to the point where there is adequate depth for mooring a boat or using a boat hoist or boat lift in common use on the waterway;
  - f. Grant an individual permit for new piers or wharves on lakes 50 acres or more, for a property on which there are three (3) or more dwelling units or commercial structures, provided that the standards in s. 30.12 (3m), Stats., are met, and provided that the piers or wharves are not located in an area of special natural resource interest, and provided that the piers or wharves do not have more than the following number of boat slips, whichever is smaller:
    - i. Four (4) boat slips for the first 50 feet of the property's shoreline footage and no more than two (2) boat slips for each additional 50 feet of the property's shoreline footage; or
    - ii. One boat slip for each dwelling unit, plus an additional number of boat slips if the additional slips are open to the public and the use of the additional slips is limited to the transient docking of boats for less than 24 hours.
  - g. Continue to accept and review individual permit applications for any new or existing pier or wharf;
  - h. Continue its practice of refraining from ordering the removal of any pier or wharf or from denying a permit for any pier or wharf unless all reasonable alternatives are considered.
3. General Provisions.
- a. Nothing in this Executive Order creates any right, benefit, or trust responsibility, substantive or procedural, enforceable at law by a person against the State of Wisconsin, its agencies, or any person.
  - b. Nothing in this Executive Order shall require the Department of Natural Resources to violate or ignore any laws, rules, directives or other legal requirements or obligations imposed by state or federal law.
  - c. This Executive Order does not limit any person's rights or obligations otherwise provided by law.

1. Create the Commission on Reducing Racial Disparities in the Wisconsin Justice System (the "Commission");
2. Direct the Commission to:
  - a. Determine whether discrimination is built into the criminal justice system at each stage of the criminal justice continuum of arrest through parole; and
  - b. Recommend strategies and solutions to reduce the racial disparity in the Wisconsin criminal justice system;
3. Provide that members of the Commission shall be appointed by the Governor to serve at the pleasure of the Governor;
4. Provide that the members of the Commission will be comprised of no more than 24 members of stakeholders including representatives from law enforcement, the financial industry, the legislature, the legal profession, the clergy, the judiciary, and the criminal justice system;

- b. Capturing 10 percent of the emerging bio–industry and renewable energy market by 2030; and
