

## NOTICE OF PRELIMINARY PUBLIC HEARING AND COMMENT PERIOD

**NOTICE IS HEREBY GIVEN** that pursuant to the authority given in ss. 43.09 (2), 115.28 (5), 115.42 (4), 115.76 (5) (b), 115.92 (3), 118.045 (3), 118.30 (2) (b) 2., 118.42 (4), 121.02 (5), 121.55 (1) (b), 227.10 (1), and 227.11 (2) (a) (intro.), Stats., the Department of Public Instruction will hold a preliminary public hearing and comment period as permitted under s. 227.136 (2), Stats., to consider promulgation of administrative rules under two separate statements of scope on proposed administrative rules:

- A rule to amend chs. PI 1, 6, 8, 11, 13, 19, 27, 37, 43; relating to technical changes to existing DPI rules as a result of 2017 Wisconsin 108 review of administrative rules, and
- A rule to amend ch. PI 7; relating to technical changes to PI 7 as a result of 2017 Wisconsin Act 108 review of administrative rules and other changes.

The hearing will be held as follows:

***Date and Time:*** Monday, April 1<sup>st</sup>, 2019, from 10:30 a.m. to 12:00 p.m.

***Location:*** GEF 3 Building, Room 041, 125 South Webster St., Madison, WI 53703

Pursuant to s. 227.135 (1), Stats., a statement of scope is prepared in advance of any rule that an agency plans to promulgate, and shall include a description of the objective rule, a description of existing policies relevant to the rule and an analysis of policy alternatives, the statutory authority for the rule, estimates of the amount of time that is expected to develop the rule, a description of entities affected by the rule, and a summary of any federal regulation that is intended to address the activities to be regulated by the rule. Pursuant to s. 227.136 (7), Stats., a preliminary public hearing and comment period on a statement of scope does not relieve the agency of its obligation to hold an agency hearing on proposed rules under s. 227.16, Stats., after proposed rules are available for review.

### *Accessibility*
