The proposed changes bring administrative rule in line with the terminology used by the federal government and national stakeholder organizations.

18. Compare With Approaches Being Used by Neighboring States (Illinois, Iowa, Michigan and Minnesota)

Neighboring states are at various stages of adopting changes to their administrative rules or regulations. The length of licensure period varies from two to four years. Various other aspects covered by these changes were included in the adjacent state survey.
