That Thomas Williams, Jonathan Harris and Lyman Clark be and they are hereby appointed commissioners to lay out and establish a state road from Helena, in the county of Iowa, via Williams' settlement, Harris' settlement, Parker and Leland's mill power on Honey creek to Adams, in the county of Sank.

Adams to Mitzer's

Sec. 2. That John B. Crawford, William H. Canfield and Emanuel Mitzer be, and they are hereby appointed commissioners to lay out and establish a state road from the town of Adams, in the county of Sauk, via the upper settlement of the Lemonwicr river to Mitzer's settlement in town fifteen north, of range four west, intersecting the county road leading to Prairie la Crosse, in the county of Crawford.

Expenses how paid.

Said road shall be altered, and laid out and returned agreeably to the provisions of an act to provide for laying out and opening territorial roads and for other purposes, passed January 11, 1840, and, when so altered and laid out, shall be a public highway according to said act, and the said board of commissioners are hereby authorized to adopt, as a part of the road hereby authorized, any part of such public roads heretofore laid out, as shall be suitable and proper.
