The People of the State of Wisconsin, represented in Senate

and Assembly, do enact as follows:

SECTION I. The Treasurer of the State is hereby author state Treasurer ised and required to pay over, upon the orders of the town to pay to the orders of the town dereif Town San Superintendents of the several towns in the county of Jeffer perintendents son, the amount of school money apportioned by the State Superintendent of Public Instruction, to each such town respectively: such order to be countersigned by the Town Clerk of the proper town, and directed to the State Superintendent of Public Instruction.

SEC. 2. Such orders so drawn as above, shall first be state superintendent of Public Instruction, and state and shall be by him endorsed, indicating thereon the amount of or to payment money apportioned to such towns, and such order so drawn and countersigned shall be sufficient vouchers for the payment of the amount of money called for thereby in the hands of the Treasurer in his settlement with the Treasurer of the county of Jefferson for such fund, so far as the same shall be paid upon such orders.

SEC. 3. This act shall take effect and be in force from and Duration of act. after its passage, and shall be and continue in force only so long as shall be necessary to close up account of school money in the hands of the Treasurer belonging to said county of

Jefferson.
