Chap. 275 *An Act to vacate a part of the Town Plat of the village of Westfield in Sauk county.*

The People of the State of Wisconsin represented in Senate and Assembly, do enact as follows:

Declared vacated.

SECTION 1. All that part of the town plat of the village of Westfield in the county of Sauk, lying north of a line sixty-three rods south of the section line between sections one and twelve in township nine, north of range six east, and parallel with said line, except the east half of block fifty-five and blocks fifty-six and fifty-seven, is hereby vacated.

SEC. 2. This act shall take effect from and after its passage.

An Act to alter the boundaries of the town of Calumet in Fond du Lac county

Chap. 276 *The People of the State of Wisconsin represented in Senate and Assembly, do enact as follows:*

Boundaries of Calumet.

SECTION 1. The south half of town seventeen, range eighteen, the south half of town seventeen, range nineteen, the north half of town sixteen, range eighteen, and the north half of town sixteen, range nineteen, in Fond du Lac county, shall constitute the town of Calumet, and elections in said town shall be held at the School House in school district number two of said town.

Boundaries of Forest.

SEC. 2. Town fifteen, range nineteen, and the south half of town sixteen, range nineteen, shall remain and constitute the town of Forest.

Boundaries of Taychedah.

SEC. 3. The south half of town sixteen and sections one, two, three, four, five and six of town fifteen, range eighteen, shall constitute the town of Taychedah.

SEC. 4. All town fifteen, range eighteen, except sections ^{Boundaries of} one, two, three, four, five and six, shall constitute the town of ^{Empire.} Empire, and the first election of said town shall be held at the School House near Micklejohn's in said town.

SEC. 5. An act of the supervisors of Fond du Lac county ^{Act of Supervisors} dividing the towns of Calumet, Taychedah, and Forest, and ^{repealed.} organizing the towns of Fountain and Empire is hereby repealed.

SEC. 6. This act shall take effect and be in force from and after its passage.
