ments from the county boards of supervisors, shall deliver, on oath, to the clerks of the boards of supervisors of their respective counties, all books, papers, documents, records, monies and property in their hands belonging to the said counties, and the several clerks of the boards of supervisors are hereby required to receive the same, and to perform all acts which such county agents are authorised to perform, and all acts done by any clerk of the board of supervisors by virtue hereof, shall have the same validity and effect as though performed by the county agent.

Penalty for vio. who shall violate the provisions of this next preceding section, lation of precessing section. SEC. 3. Any person holding the said office of county agent county, for the use of the county, ten dollars per day for every day he shall hold any of the county property contrary to the provisions of this act, the same to be recovered in an action of debt, to be brought by the county Treasurer and in his name.

SEC. 4. All acts and parts of acts contrary to the provisions of this act are hereby repealed.

Chap. 335

An Act to declare a certain street a public highway.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Street.

Section 1. That the street laid out and established by the town supervisors of the town of Madison, in the county of Dane and State of Wisconsin, on the twenty-first day of July, in the year of our Lord one thousand eight hundred and fortynine, beginning in the centre of King street in the village of Madison, in the county aforesaid, at a point where Wilson and Butler streets intersect the same, running to forty-five degrees east, in a line of Wilson to the centre of Blair street, fifty-five rods, two links; thence down Blair street to Williamson street, thence in Williamson street to Catfish river, be and the same is thereby declared to be a public highway, and may be opened and worked by the proper authorities of the said town of Madison.

An Act to incorporate the Wilmot Academy.

The People of the State of Wisconsin, represented in Senate Chap. 336 and Assembly, do enact as follows:

SECTION 1. That Archibald McIntyre, Ephraim Wilcox, E. Name of corpe-F. Barker, Simeon Lovett, S. P. Ladow, J. M. Wilber, H. ration. Deedmick, A. W. Benham, George U. Carpenter, J. Bacon and R. S. Moth and their associates, together with such persons as may hereafter be associated with them, be and they are hereby created a body politic and corporate, with perpetual succession, by the name and title of the Wilmot Academy, by which name they and their successors shall be forever known, and shall have power to sue and be sued, contract and t. ontracted with, plead and be impleaded, defend and be defended, in all courts of law and equity. Said corporation may have a common seal, ers. and shall have power to acquire, purchase, receive, possess, hold and enjoy property real and personal, and the same to sell and convey, rent or otherwise lawfully dispose of at pleasure.

SEC. 2. The stock of said company shall be divided into shares of stock shares of ten dollars each, which shall be deemed personal prop-transferable. erty, and shall be transferable on the books of said corporation in such manner as shall be directed by the - laws of said cor-

poration.

SEC. 3. Any five of the above named persons shall have power to call a meeting of said association, by giving ten days' who may can notice thereof by posting up notices in at least three of the most too. public places in the village of Wilmot in the county of Kenosha, State of Wisconsin, and by serving a written notice upon all the members of said corporation not resident in said village of Wilmot, or leaving said notice at their usual place of residence.

SEC. 4. At such first legally notified meeting, the stock-trusteehow holders shall have power to elect by ballot fifteen trustees, five elected. of whom shall be elected for one year, five for two years, and five for three years; and after the first election five trustees may be elected annually: Provided, that all trustees shall hold their office until others are elected in their place.
