

Chap. 370 An Act to appropriate to F. F. Davis, Sheriff of Fond du Lac county the sum therein named.

The People of the State of Wisconsin represented in Senate and Assembly, do enact as follows :

Sum appropriated.

SECTION 1. There is hereby appropriated to F. F. Davis, Sheriff of Fond du Lac county, to be paid out of any money in the treasury not otherwise appropriated, the sum of one hundred and fifty-one dollars and seventy-four cents, in full pay and satisfaction for board, clothing, washing and jailor's fees, in case of Bucklin, Forbes, and Powderly, State prisoners confined in Fond du Lac county jail, up to the time of their discharge.

SECTION 1. There is hereby appropriated to Peter W. Matts, out of any money in the treasury not otherwise appropriated, the sum of two hundred and eighty-five dollars and thirteen cents, in full payment for all services rendered in his official capacity as Sheriff; and for services as Crier, Fireman, and Doorkeeper, for the Supreme Court of Wisconsin, from and including the January term of said court in the year 1849, to and including the December term of 1850; and for all other services rendered in attending upon said Supreme Court.

An Act to appropriate funds for the benefit of the Institution of the Blind.

Chap. 374

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :

SECTION 1. The sum of three thousand dollars is hereby appropriated, out of any monies in the treasury not otherwise appropriated, for the construction of the proper buildings for the Wisconsin Institution for the Education of the Blind, on the site selected by the trustees of said Institution, under the charter thereof, and reported to the present session of the legislature, through the Governor.

SEC. 2. The said sum shall be paid to said board of trustees on the order of said board passed at any meeting thereof, and certified to the Treasurer of the State by the President and Secretary of said board.

SEC. 3. There is hereby appropriated, for the support of the Wisconsin Institution for the Blind, established at Janes-
