# Chap 143

### An Act to appropriate to James S. Alban the sum therein named.

The people of the State of Wisconsin represented in Senate and Assembly do enact as follows:

SECTION 1. There is hereby appropriated to James S. Alban out of any money in the state treasury not otherwise appropriated, the sum of forty-seven dollars and eightyseven cents, in full for horse and carriage hire and expenses to Oshkosh, on committee in pursuance of a joint resolution of the legislature of Wisconsin, passed February 2d, 1852.

## Chap 144

An Act to appropriate to Cary & Rounds the sum therein named.

The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows:

SECTION 1. There is hereby appropriated to Cary & Rounds the sum of twenty-six dollars and twenty-five cents in full for publishing in the Commercial Advertiser by order of the secretary of state, "proposals for printing," issued in the year 1851.

# Chap 145

#### An Act to appropriate to Baxter & Barron the sum therein named.

The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows:

SECTION 1. There is hereby appropriated to Baxter & Barron the sum of forty-five dollars and seventy-five cents, in full for publishing in the Waukesha Democrat, in the year 1851, a notice to owners of canal lands, notice of judicial election, an act submitting the question of "banks or no banks," enrollment notice from adjutant general, and adjutant general's orders, numbers two and three. J. McM. SHAFTER, Speaker of the Assembly. TIMOTHY BURNS, Lt. Governor and President of the Senate. Approved, March 23, 1852. LEONARD J. FARWELL.

As Act to cede to the United States the control and jurisdiction over certain lands therein described.

The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows:

SECTION 1. The state of Wisconsin doth hereby cede to the United States of America, full and complete control and jurisdiction over lot number three, (3,) in section number twenty-one, (21,) in township number thirty, (30,) north of range number twenty-eight, (28,) east, in the state of Wisconsin, for the purpose of improving the same by erecting a light house thereon, or for any other purpose, and the said tract of land is hereby forever exempted from taxation, so long as the same shall continue the property of the United States of America.

An Act to appropriate to B. F. Hopkins the sum of money therein named.

Chap 147

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is hereby appropriated to B. F. Hopkins out of any money in the state treasury not otherwise appropriated, the sum of eighteen dollars and twenty-five cents, in full for telegraphing for sheriff of Dane county on state business, up to December 25, 1851.
