shall deem just: *Provided*, The state shall be to no expense for the same.

An Act to vacate a part of the village plat of the town of Lowell, in Dodge county. Chap. 72.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. That all that part of the plat of the village of Lowell, in Dodge county, described as follows, to wit: Blocks, ke., vablocks eleven (11) and twelve (12) and the street between them; blocks (10) ten and the street between ten and eleven; block (9) nine; blocks two (2) and three (3) and the street between them; and the following lots in block eight: number one, two, three, four, five, twenty, twenty-one, twentytwo, twenty-three, twenty-four, twenty-five, and twenty-six; and block number seven, be and the same is hereby vacated.

SEC. 2. This act shall take effect from and after its passage.

Chap. 73.

An Act to authorize town clerks to certify to the State Superintendent the amount of money assessed for the support of schools, and to provide for levying a tax in certain cases.

The people of the State of Wisconsin represented in Senate and Assembly do enact as follows:

SECTION 1. Those towns that have not assessed, by direction of the board of county supervisors, an amount equal to one-half of the amount received from the school therised to certiffund, shall, and are hereby authorized to certify, through ^{fy}. the clerk of said towns, to the state superintendent, such "additional amounts" as have been assessed for the support of schools. Towns may levy

SEC. 2. Those towns that have not assessed, by order of the board of county supervisors, and in addition thereto. a sum of money equal to one-half the amount received from the school fund, are hereby authorized to supply such deficiency, by an immediate assessment upon the taxable property of said towns, such sum as shall be necessary; the same to be estimated and directed by the board of supervisors of the respective towns, to be levied and collected in the same manner as other taxes, and certified by the town clerk to the state superintendent, previous to the first day of April, eighteen hundred and fifty-two.

SEC. 3. The state superintendent is hereby authorized to apportion to the different towns that comply with the requisitions of this act, such sums of money as they may thereby be entitled to.

An Act to amend section twenty-two of chapter sixteen of the Revised Statutes.

Chap. 74. The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows:

Amendment.

SECTION 1. That section twenty-two of chapter sixteen of the revised statutes is hereby so amended as to require the town board of supervisors, in the several towns in the counties of Sheboygan, Dodge, Washington, and Manitowoc, in this state to assess any amount of highway tax ordered to be assessed at the annual town meeting, not exceeding fifteen mills on the dollar, in addition to the amount now authorized by law to be assessed by the said board of supervisors.
