

## Chapter 21.

*Published March 13th, 1858.*

AN ACT to amend an act entitled an act to change the names of Elizabeth Brooks and Virginia Brooks.

*The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :*

SECTION 1. The act to change the names of Elizabeth Brooks and Virginia Brooks, approved March 13, 1855, is hereby amended so as to read "Deichman," wherever the proper name "Driehman" occurs. Amendment.

SEC. 2. This act to take effect and be in force from and after its passage.

## Chapter 22.

*Published March 13th, 1858.*

AN ACT to enable the State Superintendent of Public Instruction to complete the distribution of Webster's Dictionary.

*The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :*

SECTION 1. The State Superintendent of Public Instruction is hereby authorized to distribute all of Webster's Unabridged Dictionaries heretofore or hereafter purchased by authority of the State and not yet distributed as hereinafter provided. Authorized to distribute Webster's Unabridged Dictionaries.

SEC. 2. The said Superintendent of Public Instruction is hereby required to report to the legislature the number of copies of said dictionary purchased by authority of the State, and not yet distributed, and upon the receipt of the affidavit in due form, which shall be kept on file in his office, of any town superintendent, or commissioner of schools, or superintendent of schools for any city, or the district clerk for any school district in this State, that such city, town or district has not yet been supplied with the said dictionaries or dictionary, as provided by an act, approved March 21, 1855, then the said State Superintendent of Public Instruction To make report to the legislature.

shall distribute, as per order, to said city, town or district, sending one dictionary for each public school, and department thereof, taught therein.

To charge himself with the number of dictionaries.

SEC. 3. The State Superintendent of Public Instruction upon the passage and publication of this act shall, in a book to be kept for that purpose in his office, charge himself with the number of said dictionaries now on hand, or hereafter coming into his care, purchased by authority of the State, and shall credit himself with all dictionaries distributed, as provided in this bill, specifying to what towns, cities or districts, such dictionaries are by him distributed.

False affidavit, &c.—punishment.

SEC. 4. Any town superintendent of schools, the commissioners of schools, or superintendent of schools, for any city, or the district clerk for any school district in this State, who shall be guilty of making any false affidavit to the State Superintendent of Public Instruction concerning any of the said dictionaries, or who shall upon the receipt of the same, refuse or fail to deliver it or them for the use of the school or schools in their several towns, cities or districts, shall, on conviction thereof, be punished by fine of not more than fifty dollars, nor less than ten dollars.

Expenses; by whom defrayed.

SEC. 5. All expense incurred in the further distribution of any of the said dictionaries, to any town, city, or school district, in this State, shall be incurred by the town, city, or district, receiving the same.

Binding upon successors; repealed.

SEC. 5. This act shall be binding upon the successors of, as well as upon the present State Superintendent of Public Instruction, and all acts, and parts of acts, contravening the provisions of this act, are hereby repealed, and shall take effect and be in force from and after its passage and publication.
