## Chapter 38.

*Published April 14th, 1858.*

AN Act to amend Chapter 59 of the Revised Statutes, entitled "of the alienation by deed of the proof and recording of conveyances and the cancelling of mortgages."

*The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Section eleven of chapter 59 of the Revised Statutes, entitled "of the alienation by deed of the proof and recording of conveyances and the cancelling of mortgages," be and the same is hereby amended as follows:—"Insert at the end of the third line of said section, after the words 'Notary Public,' the words 'or other' officers authorized to take acknowledgments."

## Chapter 39.

*Published March 29th, 1858.*

AN Act to amend an act entitled "An Act to divide the County of Marquette, and erect the County of Green Lake," approved March 5th, A. D. 1858.

*The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. All the records, books and papers in the office of Register of Deeds for the county of Marquette, which now, or may on the second Tuesday of April, A. D. 1858, belong and appertain to said office, shall from and after the said second Tuesday of April, A. D. 1858, be the property and records of the county of Green Lake.

Lake, and shall belong and appertain to the office of the Register of Deeds for the said county of Green Lake, and shall have the like effect, for all purposes, as if originally entered in the office of the Register of Deeds for said county.

To transcribe records.

SEC. 2. The county board of supervisors of the county of Marquette are hereby authorized, at any time they may deem it necessary, to employ some person to transcribe such portion of the records mentioned in the first section of this act, as may relate to the title of all the lands then lying and being situate within the limits of the said county of Marquette; and the person thus employed to transcribe said records, shall have access to the office of the Register of Deeds for the county of Green Lake for that purpose, copies of the records thus obtained and entered in the office of the Register of Deeds for the county of Marquette shall be of like form and effect as if originally entered of record in said county.

County of Green Lake liable to one-half the expense.  
Proviso.

SEC. 3. The county of Green Lake shall be liable to pay to the county of Marquette one-half of the expense in transcribing the records, as provided in section two of this act; *Provided*, that the whole amount for which the county of Green Lake shall be held liable to pay the county of Marquette shall not exceed two and one-half cents per folio of the records transcribed.

Repealed.

SEC. 4. So much of the provisions of the act of which this is amendatory as conflicts with the provisions of this act is hereby repealed.

SEC. 5. This act shall take effect from and after its passage.
