CHAPTER 302.

AN ACT to require the treasurer of the city of La Crosse, to receive school district orders in payment of school tax.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Treasurer of La Crosse to take school or-

SECTION 1. It is hereby made the duty of the treasurer of the city of La Crosse, in payment of any school tax, that has been or may hereafter be levied upon the taxable property in said city, to receive from any person effering to pay such school tax, the amount thereof in orders issued by the officers of school district No. 1 in said city.

Treasurer of school district to take school orders.

- § 2. The treasurer of school district No. 1, in the city of La Crosse, shall receive of and from the treasurer of the city of La Crosse in payment of any tax assessed for school purposes in said city, such orders mentioned in section one of this act, as shall have been received by such city treasurer in payment of such tax or taxes so levied for school purposes, and which have come into the hands of said city treasurer.
- § 3. This act shall take effect and be in force from and after its passage.

CHAPTER 305.

AN ACT to provide for issuing a patent of certain lands to Michal Gleiter.

Preamble.

Whereas, it appears that "Michael Gleiter," purchased at the office of the Commissioners of the Milwukee and Rock River Canal, in October, A. D. 1847, and paid for the west half of south-west quarter of section 35, in town 7, north, of range No. 15 east, and was thereupon entitled to a patent therefor: And, whereas, The duplicate receipt of the said Commissioners, by the Register and Receiver, dated October 4th, 1847, is made by an error in writing the name, to "Michael Klider," and that the patent, on file in the executive office, is made by a further error to "Michael Kilder;" therefore,

The People of the State of Wisconsin, represented in CHAPTER 367.

Senate and Assembly, do squart as follows:

SECTION 1. The Governor is hereby authorized to Governor to issue a new patent for the above described tract of sue patent. land to Michael Gleiter, upon receiving satisfactory evidence, that he is the person entitled thereto; the patent now on file, conveying the same land to Michael Kilder, to be cancelled, upon the issue of the new patent herein authorized.

§ 2. This act shall take effect from and after its passage.

CHAPTER 307.

AN ACT to authorize the Commissioners of School and University Lands, to purchase certain lands therein named, and to appropriate money for the payment for said lands.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. The commissioners of school and univer-commissioners sity lands, are hereby authorized to purchase and take of School and a deed, of the owner or owners, of the south-west Lands authorquarter of section number eight, township number ised to purthirteen, north of range number twenty-three east, in chase land. the county of Sheboygan, said land having been sold by the State in 1850 and 1858, allthough [although] it was then held by a purchaser who bought of the United States.

§ 2. There is hereby appropriated out of the princi-Appropriation. pal of the school fund, the sum of twelve hundred and fifty dollars, for the purpose of paying for said land.
