city treasury.

SEC. 18. As between grantor and grantee of any lands Rights not afaffected by this act, and as between any other persons fected. interested in such lands, their rights, liabilities, obligations and equities shall remain the same as though this act had not been passed; and the taxes and assessments. for each of the years mentioned herein, had been legally levied and collected, or the lands sold for the nonpayment thereof, in the year, under the law existing at the time said taxes and assessments should have been levied.

SEC. 19. In all cases where the credits authorized to Excess of be directed by this act shall exceed the amount of tax credits to be heretofore paid on any lot or parcel of land, or by any repaid. person for personal tax, the same shall be repaid, by the city, to the person or persons who paid the same, or for whom the same was paid, or to their legal representa-

tives.

SEC. 20. This act shall be published immediately, and shall be in force from and after its passage.

AN ACT [for an act] to perfect the geological survey of the State. The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. James Hall, of Albany, New York, is James Hall hereby constituted and appointed principal of the geo-appointed logical commission established by chapter forty, of the principal of General laws of 1857 and is hereby rested with the geological sur-General laws of 1857, and is hereby vested with such vey. general control and supervision of the geological survey of the State, as is not already expressly reserved to the several commissioners designated in said chapter.

SEC. 2. It shall be the duty of the said James Hall to To contract make a written contract with J. D. Whitney, which con-with J. whitney tract shall be approved by the Governor, providing for the completion, within the present year, of his survey and maps of the lead mines of the south western por-

tion of the State, which maps shall include the whole of such district, and shall be constructed upon a uniform scale. A contract shall also be made in the same manner with Charles Whittlesey, for the continuance of his survey of the mineral regions of Lake Superior.

SEC. 3. For the purpose of carrying into effect the

thorized to draw money provisions of the preceding section, the Governor is from treasury, hereby authorized, upon the presentation of the proper vouchers, to draw from the treasury such portion of the sum appropriated by said chapter forty, of the general laws of 1857, as was not drawn previous to the signing. of the contracts with the commissioners on the 29th day of May, A. D. 1858, and all that part of said appropriation, hereby authorized to be drawn by the Governor, which shall not be required to carry into effect the provisions of the contracts, as provided in the preceding section, shall be appropriated for the engraving of maps and drawings to illustrate the surveys therein provided for.
