AN ACT to authorize the building of ditch and bank fences, as line fences, in certain cases.

SECTION 1. Line fences on marsh or swamp land may be made by digging a ditch on the line, or by banks and ditches combined. Equal amount of material and of space occupied shall be taken from, or occupy each side of said fence: *provided*, said banks and ditches combined shall not exceed twelve feet in width; *and provided*, *further*, that in all cases said fences shall be subject to the decision of fence viewers, pursuant to law.
