

**Auditing clerks' accounts.** board [boards] of supervisors of the several counties of this state, for the services required of him [them] by the provisions of this act, shall be audited by the board [boards] of supervisors of the several counties of this state.

**Repeal.** SECTION 8. Chapter fifty-two of the general laws of 1857, chapter fifty-one of the general laws of 1858, chapter sixteen of the revised statutes, and chapter one hundred and sixty-six of the general laws of 1861, are hereby repealed.

SECTION 9. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 208.

[Published April 8, 1862.]

AN ACT to require the trustees [superintendent] of the state hospital for the insane to purchase such articles of furniture as are necessary for the west wing of that institution, of the state prison commissioner, at Waupun.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

**Furniture for west wing of insane asylum to be purchased of state prison commissioner.** SECTION 1. It is hereby made the duty of the superintendent of the state hospital for the insane, to make out a list of all such articles of cabinet furniture and upholstery as are necessary for furnishing the west wing of the state hospital for the insane, and transmit the same, with all convenient dispatch, to the state prison commissioner at Waupun; and upon the receipt of such list by the commissioner, it is hereby made his duty, without unnecessary delay, to cause to be manufactured, of good materials and in a good workmanlike manner, such articles of cabinet furniture and upholstery as are embraced in the list aforesaid, and to sell them to the superintendent aforesaid at a just and reasonable compensation: *provided*, that such articles as are required, which cannot be manufactured at the prison at reasonable prices, may be purchased by the su-

perintendent of said hospital at such other place as he may think best for the interest of the state.

SECTION 2. This act shall take effect and be in force from and after its passage.
