offering the same, by the quartermaster general, in payment for the transportation of troops and munitions of war.

Section 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 362.

[Published June 20, 1862.]

AN ACT relating to the duties of assessors and other officers, for the year 1862.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Completion assessment rolls.

Section 1. The several assessors shall, between the first Monday of July and the first Monday of September next, make out assessment rolls and perform their other duties for the year one thousand eight hundred and sixty-two, in the manner required by law, and have the same completed on or before the said first Monday of September next.

Equalization.

Section 2. The town and city boards of equalization shall meet on the first Monday of September next, and

perform their duties as required by law.

Abstracts.

Section 3. Each clerk of the county board of supervisors shall, on or before the fourth Monday of September next, make out and transmit to the secretary of state an abstract of the real and personal property in his county, in the manner required by law.

Apportionment.

Section 4. The secretary of state shall, immediately after receiving the abstracts in the preceding section mentioned, proceed to apportion the state taxes for the present year among the several counties, in the manner now required by law, and shall transmit a certified copy of such apportionment to the clerk of the county board of supervisors of each county.

Besis.

Section 5. In case the abstract in section three mentioned, shall not be received from any county or counties by the second, Monday of October next, by the secretary of state, he shall take the valuation of property as returned to his office in the year 1861, from such county or counties, as the basis upon which to apportion the state taxes to such county or counties for the

present year.

SECTION 5, [6.] Sections two and three of chapter two Repeal. hundred and seventy-six of the general laws of the year. one thousand eight hundred and sixty-two, are hereby repealed.

SECTION 6, [7.] The secretary of state shall forthwith Copies to be sent transmit printed copies of this act to the several clerks to clerks.
