

## CHAPTER 150.

[Published March 21, 1864.]

AN ACT to appropriate the sum of eight thousand dollars for the purchase of stationery for the use of the state officers and the next legislature.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

Appropriation  
for stationery.

SECTION 1. The sum of eight thousand dollars is hereby appropriated out of any money in the state treasury not otherwise appropriated, for the purchase of stationery for the use of the state officers and the legislature, for the ensuing year: The said sum of eight thousand dollars may be drawn from the treasury by the superintendent of public property, after he shall have given bonds, as required by section seven of chapter twenty-seven of the revised statutes.

## CHAPTER 151.

[Published March 24, 1864.]

AN ACT to legalize the town meeting of the town of Wheatland, Kenosha county, held February 20th, 1864.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

Meeting and  
bounty tax le-  
galised.

SECTION 1. The special town meeting of the town of Wheatland, in Kenosha county, held on the twentieth day of February, 1864, for the purpose of raising a tax of twenty-six hundred and twenty-five dollars, to pay extra bounties to volunteers into the military service of the United States, is hereby declared legal and valid for all intents and purposes for which the same was held; and all acts done in pursuance of the vote or votes of said meeting, by the officers of said town or any of them, are hereby declared valid, the same as if the law had been fully complied with in notifying or conducting said meeting.

**SECTION 2.** This act shall take effect and be in force from and after its passage.

## CHAPTER 152.

[Published March 22, 1864.]

AN ACT to vacate the village plat of Delhi.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

**SECTION 1.** The plat of blocks, lots, streets and alleys of the village of Delhi, in the town of Rushford, Winnebago county, is hereby vacated, and the same shall be assessed in future in like manner as other farming lands. Vacated.

**SECTION 2.** This act shall not be construed so as to prevent the town of Rushford from claiming (free of expense) all streets in said village which connect with the highways leading to and from said village. Certain streets may be claimed by town.

**SECTION 3.** This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 153.

[Published March 24, 1864.]

AN ACT to authorize the levy and collection of a special tax to pay bounties to volunteers, in the town of Farmington, Polk county.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

**SECTION 1.** The special town meeting held on the twenty-ninth day of December, one thousand eight hundred and sixty-three, pursuant to public notice, in the town of Farmington, Polk county, for the purpose of voting to raise money, by tax, in said town, to
