

## CHAPTER 176.

[Published March 28, 1864.]

AN ACT for the relief of the Manitowoc county agricultural society.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

When secretary of state may draw warrant on treasurer.

SECTION 1. The secretary of state is hereby authorized and directed to issue an order upon the state treasurer, in favor of the Manitowoc county agricultural society, pursuant to section five of chapter fifty-three of the general laws of 1858, in the same manner as though the annual report of said society had been received on the first day of February, 1864: *provided*, said report be on file in the office of the secretary of state on or before the first day of June, 1864.

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 177.

[Published March 30, 1864.]

AN ACT to amend an act entitled "an act to incorporate the city of La Crosse," approved March 14, 1866.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Treasurer to receive a fixed salary.

SECTION 1. The treasurer of the city of La Crosse shall receive as compensation for his services, in lieu of all fees and emoluments now by law received by him for such services, a salary to be fixed and prescribed by the common council of said city, as hereinafter provided.

When salary to be fixed.

SECTION 2. At the first regular meeting of the common council of the city of La Crosse, in the month of March, in each year, said common council shall fix and determine the amount of the annual salary that the treasurer of said city shall receive, except for the year

1864, for which year said salary may be fixed and determined by said common council at any time before the charter election for said year.

SECTION 3. The salary thus fixed and determined upon, shall be paid out of the city treasury out of any moneys not otherwise appropriated, and may be paid at the end of every quarter. How salary to be paid.

SECTION 4. The fees now allowed by law to the treasurer of said city, shall be collected by him and paid into the city treasury for the use of said city. Fees to be paid into treasury.

SECTION 5. All acts and parts of acts conflicting with this act, are, for the purposes of said act only, hereby repealed. Repeal.

SECTION 6. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 178.

[Published March 28, 1864.]

AN ACT to change the time of holding annual meetings in school district number five, in the town of Wauwatosa.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

SECTION 1. The annual meetings in school district number five, in the town of Wauwatosa, shall hereafter be held on the last Monday of August, in each year. The hour of such meeting shall be seven o'clock in the afternoon, unless otherwise ordered by a vote of the district, duly recorded, at the last annual meeting. To be held last Monday of Sept.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
