## CHAPTER 274.

[Published May 20, 1865.]

AR ACT to authorize the board of supervisors of the town of Blooming Grove, Dane county, Wisconsin, to transact certain business in an office in the adjoining city of Madison.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The board of supervisors of the town May trans of Blooming Grove, Dane county, Wisconsin, shall Madison. have power to transact business relating to their office and their town, in an office in the city of Madison, Dane county, Wisconsin: provided, that the holding of all general and special elections by the residents of Blooming Grove, and all business pertaining thereto, shall be held and transacted in said town.

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 275.

[Published May 19, 1966.]

AN ACT to authorize the state superintendent of public instruction to apportion school moneys to the town of La Valle, Sauk county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The state superintendent of public in-Apportunian struction is hereby authorized and directed to apport of La Valle, in the county of Sauk, the full amount of school moneys for the present year that the said town would have been entitled to, if the annual report of the clerk of joint district number eleven (11) of La Valle and Ironton, had been made at the time prescribed by law; and the town clerk of said that to come town of La Valle is hereby directed to apportion to No. 11. said joint district number eleven (11) its full share of . all school moneys coming into the hands of the town

treasurer during the present year, the same as if the report of the clerk of said district for the year 1864, had been received by him in due time.

This act shall take effect and be in force Section 2.

## CHAPTER 276.

[Published May 19, 1866.]

AN ACT to authorize the state superintendent of public instruction to apportion school moneys to the town of Randolph, Columbia county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The state superintendent of public in-

struction is hereby authorized and directed to apportion to the town of Randolph, in the county of Columbia, the full amount of school moneys to which said town would have been entitled for the present year, if the report of the clerk of the joint district number two (2) of said town for the year 1864, had been made at mid to district the time prescribed by law; and the town clerk of said town is hereby directed to apportion to said joint district its full share of all school moneys coming into the hands of the town treasurer for the present year, the same as if the report of the clerk of said district for 1864, had been received by him within the time prescribed by law.
