The city treasurer shall keep, in a book provided for that purpose, a true account of all fees received by him for the collection of taxes in said city, or for any other purpose, which book shall be open at all times to the inspection of the mayor or common council of said city, and shall pay into the general fund of said city, for the benefit of the city, all sums of money so received by him for fees; and the mayor and common council of said city shall fix by resolution the salary of the city treasurer, at such amount as they may deem just and proper, not exceeding the amount of twelve hundred dollars for any one year, which amount so fixed shall be paid to said city treasurer as other salaries are paid to officers of said city, in full compensation for his services as such treasurer."

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 360.

[Published April 8, 1865.]

AN ACT to amend chapter ten of the revised statutes, entitled  
"of state officers."

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Section 8 of chapter 10 of the revised statutes, is hereby amended, as follows: By striking out the words "twelve hundred," in the fourth line, and inserting the words "sixteen hundred" in lieu thereof, so that the latter clause of said section will read as follows: "The salary of the private secretary of the governor shall be sixteen hundred dollars per annum, to be paid quarterly, as other salaries are paid."

Salary of governor's private secretary.

SECTION 2. The sum necessary to carry into effect the provisions of this act, is hereby annually appropriated out of the general fund.

Appropriation.

SECTION 3. All acts or parts of acts inconsistent with the provisions of this act, are hereby repealed.

SECTION 4. This act shall take effect and be in force from and after its passage.

## CHAPTER 361.

[Published April 10, 1865.]

AN ACT to increase the compensation now allowed by law to certain officers and employees of the state prison, and to appropriate a certain sum of money for such purpose.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Per diem of state  
prison officers  
and employees.

SECTION 1. The following officers and employees of the state prison, shall each receive for his services the sum of fifty cents per day, in addition to the amount now allowed by law: The deputy warden, the overseers in the several shops, and all other overseers and keepers in the several departments of the prison; which amount shall be paid by the commissioner at the times and in the manner provided in section six of chapter 188 of the revised statutes.

Appropriation.

SECTION 2. There is hereby appropriated to Henry Cordier, state prison commissioner, out of any money in the state treasury not otherwise appropriated, the sum of three thousand dollars, to carry into effect the provisions of this act.

SECTION 3. This act shall take effect and be in force from and after its passage.
