

## CHAPTER 186.

[Published April 28, 1866.]

AN ACT relating to issues, mode of trial and judgment in civil actions, and amendatory of section 36 of chapter 182 of the revised statutes.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

Judgment—when  
and how docketed

SECTION 1. Section 36 of chapter 182 of the revised statutes, is hereby amended, by adding to said section, after the word “rendered,” in the 12th line thereof, the following: “*provided*, that in cases where the collection of the judgment or the sale of the real estate upon which the same may be a lien, shall be delayed or prohibited by law, the time of such delay or prohibition shall not be taken or counted as any part of the said ten years.”

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 187.

[Published April 28, 1866.]

AN ACT to amend section 54 of chapter 19 of the revised statutes, relating to highways and bridges.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

Road not to be  
laid through  
orchard, &c.  
without consent  
of owner.

SECTION 1. Section fifty-four of chapter nineteen of the revised statutes, is hereby amended, so as to read as follows: “Section 54. No public or private road shall be laid out through any orchard or garden, without the consent of the owner thereof, if such orchard have been set out two years or more, or if such garden have been cultivated as such two years or more; nor shall any such road be laid out through any buildings, or any fixtures or erections used for educational or chaitable purposes, or for the purposes of trade or manufactures, or any yards or inclosures necessary to the use and en-

joyment of any such buildings, fixtures or erections, without consent of the owner."

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 188.

[Published April 28, 1866.]

AN ACT to amend section 1 of chapter 24 of the session laws of 1863, entitled "an act to amend section 55 of chapter 187 of the revised statutes, entitled 'of evidence.'"

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Section one of chapter twenty-four of the general laws of 1863, entitled "an act to amend section fifty-five of chapter one hundred and thirty-seven of the revised statutes, entitled 'of evidence,'" approved March 10, 1863, is hereby amended, by inserting the words "or court commissioner," after the words "county judge," where they occur in the seventh line from the top in said section; also, by inserting the words "or court commissioner," after the word "judge," in the eighth line from the bottom of said section.
