

## CHAPTER 67.

[Published April 19, 1866.]

AN ACT to authorize the superintendent of public instruction to procure the publication of the school code.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

Publication of school code.

SECTION 1. The superintendent of public instruction is hereby authorized to procure the publication, in pamphlet form, of eight thousand copies of a school code, containing all the school laws of the state, together with necessary instructions and forms, and plans and specifications for school houses, with a suitable index ; and when printed, he shall furnish a copy of said code to each school district clerk, each town clerk, and each county and city superintendent of schools in the state.

Appropriation

SECTION 2. There is hereby appropriated out of any money in the state treasury not otherwise appropriated, a sum sufficient to meet the expense of printing the said code, as above set forth.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 68.

[Published April 14, 1866.]

AN ACT to exempt property of the American bible society and its auxiliaries and branches, from taxation.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

Exemption.

SECTION 1. That all bibles and testaments owned in this state by the American bible society, organized in the city of New York, in the year 1816, or by any of its auxiliaries or branches, together with all other personal property necessary for the prosecution of their objects as a bible society, shall be exempt from all assessments and taxation whatever.

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 69.

[Published April 18, 1866.]

AN ACT to provide for the collection of certain agricultural and manufacturing statistics, for the year 1865.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. It shall be the duty of the assessors of the several towns and cities in this state, at the time of making the annual assessment of personal property for the year 1866, to collect the statistics in their several towns and cities, of the following mentioned articles grown, raised or manufactured during the year 1865:

Collection of statistics for 1865.

Apples; bushels, valuation.  
 Agricultural implements and machinery; valuation.  
 Barley; acres, bushels, valuation.  
 Boot and shoes; pairs, valuation.  
 Beans and peas; acres, bushels, valuation.  
 Buckwheat; acres, bushels, valuation.  
 Butter; pounds, valuation.  
 Cabinet ware; valuation.  
 Capital invested in manufactures.  
 Cattle and calves on hand; number and valuation.  
 Cattle and calves slaughtered; number and valuation.  
 Cheese; pounds, valuation.  
 Clover seed; pounds, valuation.  
 Copper ore; tons, valuation.  
 Copper manufactures; valuation.  
 Corn; acres, bushels, valuation.  
 Cotton goods; yards, valuation.  
 Drain tiles; number, valuation.  
 Earthen ware; valuation.  
 Flax; pounds, valuation.  
 Flax seed; bushels, valuation.  
 Grapes; pounds, valuation.  
 Honey; pounds, valuation.
