In addition to the remedies provided by sections 100 and 101 of chapter 18 of the revised statutes, and by other laws of this state for the collection of delinquent personal property taxes, it is hereby further provided, that the county treasurer may issue a special warrant, in any convenient and proper form, to the sheriff of his county, or to the sheriff of any other county in this state, commanding the collection of the delinquent personal property tax of any person or persons so appearing delinquent upon the books of his of-Such warrant may provide for the collection of fice. the delinquent tax of any one or more individuals, in the discretion of the county treasurer, and may be issued at any time while said tax remains unpaid.
