## CHAPTER 133.

[Published April 19, 1867.]

AN ACT to amend section nine of chapter one hundred and twelve of the revised statutes, entitled "of guardians and wards."

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

When personal property of non-resident ward may be removed out of state.

SECTION 1. Section nine of chapter one hundred and twelve of the revised statutes, entitled "of guardians and wards," is hereby amended, so as to read as follows: "Section 9. In all cases when any guardian and his ward may both be non-residents of this state, and such ward may be entitled to personal property of any description in this state, including the proceeds of any sale of the real estate of such ward, such guardian, on producing satisfactory proof to the county court of the proper county, by certificates, according to the act of congress in such cases, that he has been duly appointed, and has as guardian given bond and security in the state in which he and his ward reside, in double the amount of the value of the property or proceeds, and it is found that a removal of the property or proceeds will not conflict with the terms of limitation attending the right or title by which the ward owns or holds the same, then any guardian may demand or sue for and remove any such property or proceeds to the place of residence of himself and ward."

SECTION 2. This act shall take effect and be in force from after its passage and publication.
