hereby authorized to appoint, each for his own court a crier whose duty it shall be to open and adjourn court, and to assist in preserving order in court, who shall hold his office during the pleasure of the judge appointing him, and shall receive for his services two dollars and fifty cents per diem during his actual attendance in court, to be paid out of the county treasury of the county of Milwaukee.

Sheriff to keep deputies in attendance, and their per diem.

Section 2. The sheriff of Milwaukee county is is hereby required to keep in attendance upon each of said courts, during the session thereof, as many deputy sheriffs as the judge of said court shall require, and no more, and each deputy sheriff in actual attendance upon said courts, shall receive for such, and for actual attendance only, two dollars and flity cents per diem, to be paid out of the county treasury of said county: provided, that neither crier nor deputy sheriff shall receive compensation for any day when the court shall not have been in session, doing business.

SECTION 3. This act shall take effect and be in force from and after its passage and publication, and all acts and parts of acts conflicting with or superseded by

the provisions of this act are hereby repealed.

CHAPTER 116.

AN ACT to annex a part of the county of Ashland to the county of Bayfield.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Set off from Ashland and annexed to Bayfield.

SECTION 1. All the following described lands are hereby detached and set off from the county of Ashland and annexed and attached to the county of Bayfield, viz: townships forty-three (43), forty-four (44), forty-five (45), forty-six (46) and forty-seven (47), of range five (5) west, forty-three (43) and forty-four (44) of range seven (6), forty-three (43) and forty-four (44) of range seven

(7), forty-three (43) and forty-four (44) of range eight (8), forty-three (43) and forty-four (44) of range nine (9) west of the fourth principal meridian, and said territory so annexed shall become and be a part of the town of Bayfield.

Section 2. This act shall take effect and be in

force from and after its passage and publication.

CHAPTER 117.

[Published Merch 28, 1869.]

AN ACT to provide for a system of county highways in Brown county, and for the adoption of such system by other counties.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The county board of supervisors of Board of super-Brown county shall hold a special meeting on the first visors shall appoint overseer Monday in May, A. D. 1869, for the purpose of electing some suitable person to serve as overseer of county sation. highways and for fixing his compensation. The said board shall at the same meeting declare by resolution such highway or highways or parts thereof as they deem to be of general interest to the whole county, to be county highways. Such resolution shall be published in some newspaper in the county for three successive weeks next after its passage, and thereafter the highways so declared shall remain "county highways" until such resolution is duly revoked.

Section 2. Whenever at any meeting of said county county highboard, any highway or highways shall be declared and ways to be re-published as "county highways," in the manner above expense. provided, such highways shall after the first day of March succeeding the passage of such resolution, be repaired and maintained at the county expense, and shall cease to be in any manner under the charge and superintendence of any officers of the towns through which they pass.
