

1864, and under the same restrictions and provisions, and all applications for extra pay under this act, shall be filed with the secretary of state on or before the first day of March, 1872, and the secretary of state shall require satisfactory proof of such service.

**Appropriation.** SECTION 2. There is hereby appropriated, out of any moneys in the state treasury not otherwise appropriated, a sum sufficient to pay all claims which shall be presented and allowed under the provisions of this act.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 113.

[Published April 4, 1870.]

AN ACT to appropriate to the Soldiers' Orphans' Home the sum of forty thousand dollars.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

**Appropriation.** SECTION 1. There is hereby appropriated to the Soldiers' Orphans' Home out of any money in the treasury belonging to the general fund, not otherwise appropriated, the sum of forty thousand dollars, being payment in full for buildings, repairs and current expenses; and also the sum of one hundred dollars each, to every soldier's orphan whose father was killed or died in the late war in the volunteer service of this state, who is supported by charity in any part of the state: *provided*, that the same prerequisites which are required for admission into the Soldiers' Orphans' Home, shall also be required to entitle such orphan to the benefit of this act, and it shall be the duty of the mayor or president of any incorporated city or village, or the chairman of the board of supervisors of any town, to make out and furnish to the secretary of state, the evidence and papers necessary to entitle each of said orphans to such appropriation.

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 114.

[Published March 24, 1870.]

AN ACT to authorize counties, cities, towns and villages to aid in the construction of the Portage, Stevens Point and Superior Railroad.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

SECTION 1. It shall be lawful for the proper officers of any county through any portion of which any part of the railroad of the Portage, Stevens Point and Superior Railroad Company of [or] the company with which said company shall at any time unite or consolidate, or any incorporated village or city in such county, town, incorporated city or village to aid in the location and construction of any portion of such road, and for the purchase of right of way and depot grounds, and for like purposes to issue the bonds of any such county, town, incorporated city or village in such sum or sums, and upon such terms and conditions as shall be agreed upon by and between such county, town, incorporated city or village, and the said Portage and Superior Railroad Company, or the said Winnebago and Superior Railroad Company, or any railroad company which may be consolidated by or grow out of the two said companies ; but no such tax shall be levied, nor bonds issued by any such county, town, incorporated city or village, unless a majority of the legal voters of such county, town, incorporated city or village, voting on the question, shall first have voted in favor of such tax or the issuing of such bonds, in the manner hereinafter provided.
