There is hereby appropriated to John Beyd the sum of one hundred and seventy-five dollars out of any money in the treasury belonging to the general fund not otherwise appropriated, which shall be in full compensation for all trouble and expense incurred by said John Boyd in contesting the seat of H. S. Town, now representing the 20th senatorial district, and to O. B. Lapham the sum of seventy-nine dollars and ninety cents out of any money in the treasury belonging to the general fund not otherwise appropriated, which shall be in full compensation for all trouble and expense incurred by said O. B. Lapham in contesting the seat of S. W. Pierce, of Adams county, in the assembly in 1870.

Warrant to be

SECTION 2. The secretary of state is hereby required to draw his warrant on the treesury in favor of the said John Boyd and O. B. Lapham for the amounts above

specified, and the treasurer is hereby required to pay the same
