

## CHAPTER 36.

[Published March 4, 1871.]

AN ACT to provide for the purchase of three hundred copies of Webster's Dictionaries.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. The state superintendent of public instruction is hereby authorized and directed to purchase, on behalf the state, three hundred copies of Webster's Unabridged Dictionary, at a cost not to exceed eight dollars per copy. May purchase dictionaries.

SECTION 2. The said dictionaries, when procured, shall be distributed in accordance with the provisions of chapters sixteen and thirty-two of the general laws of 1867. How distributed.

SECTION 3. There is hereby appropriated out of the income of the school fund a sum sufficient to pay for dictionaries above provided for. Appropriated.

SECTION 4. This act shall take effect from and after its passage and publication.

## CHAPTER 37.

[Published March 6, 1871.]

AN ACT to amend section one of chapter 77 of the general laws of 1868, entitled "an act to provide for the incorporation of bible and literary societies."

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Section 1 of chapter 77 of the general laws of 1868, entitled "an act to provide for the incorporation of benevolent, bible and literary societies," is hereby amended so as to read as follows: "Section 1.

Any number of persons, not less than five, may unite May organize association.

for the purpose of organizing an association for benevolent, literary, charitable, musical, boating, sailing, scientific, religious and missionary purposes, and for the distribution of the bible or parts thereof. They may sign and acknowledge before some proper officer authorized to take acknowledgment of deeds, a certificate in writing, in which shall be stated the name of such association, the names of the corporators and the name of the city, village, town and county in which the operations of such association are to be conducted. Such certificate shall be filed in the office of the register of deeds of the county in which the business of the association shall be carried on, and a duplicate thereof shall be filed in the office of the secretary of state."

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 38.

[*Published March 6, 1871.*]

AN ACT to repeal chapter 103 of the general laws of 1866 and other acts amendatory thereof, relating to the sale of lands for unpaid taxes, and the conveyance and redemption thereof.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Repealed.

SECTION 1. Chapter 103 of the general laws of 1866, and all acts amendatory thereof, (*be and the same*) are hereby repealed.

SECTION 2. This act shall take effect and be in force from and after its passage.
