SECTION 2. All acts and parts of acts, contravening Conflicting acts repealed. the provisions of this act, are hereby repealed.

CHAPTER 268.

[Published March 13, 1875.]

AN ACT to amend an act entitled "an act to provide for the incorporation of villages."

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section three, of chapter forty-four, of the revised statutes, is hereby amended by inserting in the fourth line thereof, between the words "town" and "or" the word "village" so that said section when amended shall read as follows: Any mortgage of personal property, one copy thereof may be filed and how to be in the office of the clerk of any town, village or city filed. where the mortgager executing the same resides, or in case he is a non-resident of the state, then in the office of the clerk of the town, village or city where the property mortgaged may be at the time of executing said mortgage; and such clerk shall endorse on such instrument or copy the time of receiving the same, and shall keep the same in his office for the inspection of all persons. Mortgages so filed shall be as valid and binding upon all persons as if the property thereby mortgaged had immediately upon the execution of such mortgage been delivered to and the possession thereof retained by the mortgagee.

SECTION 2. The village clerk shall perform the same Duties and fees duties and be entitled to the same fees as the clerks of village clerk. of the several towns in like cases.
