CHAPTER 97.

[Published March 4, 1875.]

AN ACT to amend section 46, of the Wisconsin School Code, and relating to common schools.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

Amended.

Section 1. Section 46, of the Wisconsin School Code, is hereby amended by adding to the end of said section as follows: But any meeting of the district board held within the limits of the school district shall be considered legally constituted to do business, provided all the members are present, and do each, then Business may and there, consent to call it a meeting of the district be done at any meeting of dis-board; and provided further, that the board, at any tries board. such meeting not previously called shall not have such meeting not previously called, shall not have power to purchase school apparatus, or to transact such other business as is provided for in sections 47, 51, and 53, of said code; and it shall be the duty of the district clerk to record the transactions of such meetings, said record to be signed by the district clerk and the other members of the district board.

SECTION 2. This act shall take effect from and af-

ter its passage and publication.

CHAPTER 98.

AN ACT to amend section 35, of chapter 243, of the laws of 1874, entitled, "An act relating to public printing."

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

Amended.

Section 1. Section 35, of chapter 243, of the laws of 1874, is hereby amended by adding to said section the following proviso: Provided, That said work of printing, stereotyping, and binding can be done in this state as well and at as low a price as elsewhere. Section 2. This act shall take effect and be in

torce from and after its passage and publication. Approved March 1, 1875.

CHAPTER 99.

[Published March 6, 1875.]

AN ACT to amend chapter 59, of the private and local laws of the year 1868, entitled, "an act to incorporate the city of Fond du Lac, and to repeal chapter 124, of the private and local laws of 1867, entitled, 'an act to consolidate and amend the act to incorporate the city of Fond du Lac, and the several acts amendatory thereof, and to amend an act to consolidate the several school districts of the city of Fond du Lac, and the several acts amendatory thereof."

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Section one, of chapter five, of said Ch. 59, P. a L. chapter 59, is hereby amended by adding thereto the amended. following: And shall have the control and supervision of the police of said city, and is hereby authorized to appoint special policemen whenever the safety and good order of the city shall in his judgment require the same upon special or unusual occasions.

Amended.

Section 2. Subdivision or paragraph eighteen, of section five, of chapter six of said chapter fifty-nine, is hereby amended by adding thereto the following, viz: And the common council of said city are hereby authorized and empowered to declare by resolution any street of said city a nuisance, and to close or shut up the same whenever in its judgment any such street of the city shall be in an unsafe condition for ordinary travel and use, and so far out of repair as to render travel dangerous thereon or over the same.

Section 3. Section three, of chapter twelve, of said chapter fifty-nine, is hereby amended so as to read as city derk to follows: Section (3) three. If such petition shall be given. represent that it is necessary to take private property for public use, against the consent of the owner thereof, and such petition be granted by the common council, the city clerk shall thereupon cause notice to be given to the owner or occupant of such lands proposed to be taken, describing the lands and premises proposed to be taken, by publication in the official paper of the city for at least two successive weeks, at
