

## CHAPTER 163.

[Published March 15, 1876.]

AN ACT to legalize certain illegalities in certificates of tax sales.

*The people of the State of Wisconsin, represented in senate and assembly, do enact as follows:*Tax certificates  
legalized.

SECTION 1. All irregularities in the certificates of tax sale in Monroe county for the year 1872, on account of the insertion of an erroneous date, as the day of sale, in said certificates of tax sale, are hereby legalized and made as valid and effectual for all purposes, as if such error had not been made.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 164.

[Published April 5, 1876.]

AN ACT to regulate and fix the number of petit jurors in Marquette county.

*The people of the State of Wisconsin, represented in senate and assembly, do enact as follows:*Selection of  
jurors.

SECTION 1. The board of supervisors of Marquette county shall at each annual session thereof, select from the lists returned from the several towns for that purpose, as required by law, the names of seventy-two persons, good and lawful jurors, to serve as petit jurors in the circuit court for the ensuing year.

SECTION 2. From the names selected and returned by the board of supervisors as provided in section one of this act, the clerk of the circuit court, at the time and in the manner now provided by law, shall draw the names of but twenty-four persons, to serve as petit jurors for each term of court, to be held in said county unless the circuit judge for said county shall sign his order in writing, at least fifteen days before the sitting of the court in said county, commanding such clerk to draw a greater number of jurors than is herein provided for.

SECTION 3. This act shall supersede and take the place of all other acts and laws of this state, so far as the same relates to the process and proceedings of selecting petit jurors in Marquette county. Act to supersede other acts,

SECTION 4. This act shall take effect and be in force from and after the first day of June, 1876.

## CHAPTER 165.

[Published March 16, 1876.]

AN ACT conferring certain powers upon the town board of supervisors of the town of Bayfield, Bayfield county.

*The people of the State of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. The board of supervisors of the town of Bayfield are hereby authorized to construct sewers and drains along the public streets and alley-ways in the village of Bayfield, in the town of Bayfield, for the purpose of carrying waste water from public hydrants, and to provide proper sewerage for the village of Bayfield; *provided, however*, that at the annual town meeting, the electors of said town of Bayfield shall order the same done, and vote to raise a tax for the purpose named in this section. Authority of town board to construct sewers and drains.

SECTION 2. The town board of supervisors of the town of Bayfield are hereby authorized to annually levy a tax sufficient to pay the Bayfield Hydraulic Company for the use of hydrants, and water used from the same, at fires; *provided, however*, that said tax shall not exceed one mill on the dollar valuation of the property of said town. Authority to levy special tax.

SECTION 3. This act shall take effect on and after its passage and publication.
