in said city and ward, for the year 1876, at which election the proper authorities shall provide a separate ballot box, in which the ballots cast on that question may be deposited. Said ballots may be written or printed, and shall be substantially in the following form: "For Walnut street bridge tax," and "Against Walnut street bridge tax." Said votes shall be canvassed and returned in the same manner as other votes cast at said election in said ward, and if a majority of said votes shall be in favor of said tax, then the same shall be levied and collected as hereinbefore provided.

Tax to be paid over to city treasurer of Green Bay.

Section 3. When the said annual tax shall have been collected, it shall be paid over by the city treasurer of the city of Fort Howard, to the treasurer of the city of Green Bay; provided, that before any such payment shall be made, the common council of the city of Green Bay, shall, by resolution duly adopted, authorize the said treasurer to receive the same, and agree that the city of Green Bay shall keep and maintain the said bridge in repair, and indemnify and save harmless, the city of Fort Howard, and the said second ward from all loss, damage, cost, and expense, by reason of said bridge becoming at any time insufficient, or out of repair, and the acceptance of said money by the said treasurer of the city of Green Bay, shall be deemed in law a contract upon the part of said city of Green Bay to perform the conditions hereinbefore set forth.

Section 4. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 226.

AN ACT to provide for the publication of the transactions of the Northern Wisconsin Agricultural and Mechanical Association.

The people of the State of Wisconsin, represented in senate and assembly, do enact as follows:

Report of association to be printed. Section 1. There shall be printed annually by the state printer on the order of the commissioners of public printing, two thousand five hundred copies of the transactions of the Northern Wisconsin Agricul-

tural and Mechanical Association and such other matters pertaining to the industry of the state, as shall be deemed most important; provided, that the number of printed pages of said volume of transactions shall not exceed five hundred; said transactions shall be printed on good book paper and bound in muslin cover uniform in style with the previous volumes published.

Section 2. The transactions of the Northern Wis- How printed consin Agricultural and Mechanical Association, so distributed. published, shall be distributed as follows: four hundred copies to the legislature, twenty-five copies to the State Historical Society, twenty-five copies to the Academy of Science, Arts and Letters, fifty copies to the State Agricultural Society, and the remainder to the Northern Wisconsin Agricultural and Mechanical Association.

Section 3. There is hereby appropriated out of the Appropriation. general fund a sufficient sum of money for the printing of said volumes annually.

Section 4. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 227.

AN ACT to provide for the recording of the lands of the Wisconsin Railroad Farm-Mortgage Land Company, in the register's office of the several counties in which such lands are situated.

The people of the State of Wisconsin, represented in senate and assembly, do enact as follows:

Section 1. The secretary of state shall cause to be secretary of made out lists of the lands of the Wisconsin Railroad state to make Farm-Mortgage Land Company, situated in the seve- and transmit to ral counties of this state. Said lists shall contain full deeds. descriptions of all such lands in any county, and shall be certified to by said secretary of state under his hand and the seal of his office, and on or before the first day of July, A. D. 1876, such lists certified to as aforesaid, shall be transmitted to the register of deeds of the several counties respectively, in which such lands are situated.
