## CHAPTER 104.

AN ACT to amend section six of chapter two hundred and fifty-nine of the general laws of 1878, entitled an act to lay out and establish a state road from Wolf river in Shawano county to Wausau in Marathon county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section six of chapter two hundred Levying of highway tax. and fifty-nine of the general laws of 1878 is hereby amended so as to read as follows: Section 6. There shall be levied for the year 1878, upon all taxable property in townships number twenty-seven, twentyeight and twenty-nine of ranges eleven and twelve east, in the county of Shawano, and townships twentyseven, twenty-eight and twenty-nine of ranges eight, nine and ten east, in the county of Marathon, a highway tax of five mills on the dollar, and for the years 1879 and 1880, upon the taxable property in townships twenty-eight and twenty-nine of ranges eleven, twelve and thirteen east, in the county of Shawano, and range nine and range ten east of townships number twentyeight and twenty-nine, in the county of Marathon, a highway tax of two and one-half mills on the dollar, to be expended wholly and only for the purpose of opening and improving the road herein provided for; and the several town boards of supervisors in which the above described townships are located are empowered, authorized and required to levy and collect said tax and pay the same to the commissioners herein appointed to receive and disburse the same, and for the purpose of aiding in the construction of said road the said board of supervisors shall annually appropriate and pay the drainage fund received by them for the several townships of land herein mentioned for each of said years, and all other funds levied and appropriated by or under the provisions of this act, to Charles D.

Road commiseloners. Wescott, of Shawano county, and J. M. Smith and August Kickbusch, of Marathon county, who are hereby appointed commissioners to construct said road and let the necessary contracts and perform the usual duties pertaining thereto, and to receive and disburse the funds levied and appropriated for such purpose, said commissioners to receive the same per diem as other commissioners herein named : provided, that said Charles D. Wescott shall receive and disburse the money levied and appropriated in Shawano county, and J. M. Smith and August Kickbusch, shall receive and disburse the money levied and appropriated in Marathon county, and construct the road therein.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
