## CHAPTER 122.

AN ACT to amend section thirty-two of chapter one hundred and seventy-one of the laws of 1878, relating to public schools in the city of Watertown.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Section thirty-two of chapter one hundred and seventy-one of the laws of 1878, is hereby amended so as to read as follows: Section 32. Whenever in the opinion of the board of education it shall become necessary to erect a union or high school building, it shall report such fact together with an estimate of the probable cost of such building, to the common council of said city, and the common council is hereby authorized, if it deem it expedient and approve of the same, to levy a tax in addition to the school taxes that may be levied under section fourteen of this act, for the purpose of erecting such union or high school building: *provided, however, that said tax shall not exceed the sum of six thousand dollars in any one year, and the proceeds of such tax shall in no case be appropriated to any other purpose.*

Erection of union or high school buildings.

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 123.

AN ACT to lay out and establish a state road from the village of Hillsborough, in the county of Vernon, to the village of Union Centre, in the county of Juneau.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. John W. Allen and Frederick Schnell, of Vernon county, and Henry Schunemann, of Juneau county, are hereby appointed commissioners to lay out and establish a state road from the village of Hillsborough, in the county of Vernon, to the centre of the highway west of and near Warren Kimball's barn, in the county of Juneau.

Commissioners; location of road.

Map and field notes.

SECTION 2. The said commissioners shall make or cause to be made by some competent surveyor, a plain and legible copy of the map and field notes of the survey of the said road as by them located, and file one copy of the same with the town clerks of the towns of Hillsborough and Wonewoc, and one copy of the said map and field notes with the county clerks of the counties of Vernon and Juneau.

Per diem of commissioners.

SECTION 3. The said commissioners shall receive three dollars per day for the time actually employed and necessarily spent by them in laying out and establishing said state road, which shall be in full for all services rendered by them ; and they are hereby authorized, in their discretion, to employ some competent surveyor to make the survey and maps herein provided for, and at such price per day as may be by them agreed upon, not exceeding five dollars per day for the time actually and necessarily employed in such work.

Expense, how borne.

SECTION 4. The expense of laying out and establishing said road shall be borne by Vernon county and private donation, and no expense whatever shall be made, or incurred, or borne by Juneau county by reason of the provisions of this act.

Levy of tax.

SECTION 5. The town of Hillsborough, in the county of Vernon, and Wonewoc, in the county of Juneau, are hereby authorized to levy, at the next town meeting, a tax sufficient to open said road.

SECTION 6. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 124.

AN ACT relating to the apportionment of state taxes and amendatory of section one thousand and sixty-nine of chapter forty-eight of the revised statutes.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

State board of assessment to meet annually.

SECTION 1. Section one thousand and sixty-nine of chapter forty-eight of the revised statutes is hereby amended so as to read as follows : Section 1069. The secretary of state, state treasurer and attorney general shall constitute a state board of assessment. Said board shall meet at the capitol, in the city of Madison, on the third Wednesday of May in the year 1879, and
