wild-cat or lynx, unless the county in which said wolf, wild-cat or lynx shall be killed, shall pay to the person a reward equal to the amount named in section one (1) of this act.

Section 7. All acts or parts of acts contrary to the provisions of this act are hereby repealed.

Section 8. This act shall take effect and be in force from and after its passage and publication. Approved March 21, 1883.

AN ACT relating to corporations, and amendatory of section 1791 of chapter 86 of the revised statutes.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 1791 of chapter 86 of the Relating to revised statutes, entitled, "of the organization of corporations," is hereby amended by adding thereto the following, viz.: Whenever articles of association have heretofore, and since the passage of said chapter 86, been filed in the office of the secretary of state, or in the office of the register of deeds, for any of the purposes for which corporations may be formed under said chapter 86, and an organization has been formed under and pursuant to said articles, such organization is hereby declared to be legal, and the corporation to be duly

organized; provided, such corporation, within six months after the passage and publication of this act, perfect its organization and the laws then existing.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 120.

AN ACT to appropriate the sum of money therein named to the Wisconsin Wool Growers' and Sheep Breeders Associa-
