## CHAPTER 142.

AN ACT to appropriate the sums of money therein named to the charitable, reformatory and penal institutions of the state.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Appropriation

SECTION 1. There is hereby appropriated, out of any money in the general fund not otherwise appropriated, to the institutions below named the following sums of money for the purposes specified, to-wit: To the Wisconsin state hospital for the insane, for current expenses, including painting and necessary repairs, to January 1, 1884, sixty-five thousand dollars (\$65,000); for current expenses including painting and necessary repairs, to January 1, 1885, sixty-five thousand dollars (\$65,000); for purchase of Farwell farm, seven thousand dollars (\$7,000). To the northern hospital for the insane, for current expenses, including painting and necessary repairs, to January 1, 1884, seventy-four thousand dollars (\$74,000); for current expenses, including painting and necessary repairs to January 1, 1885, seventy-four thousand dollars (\$74,000). To the Wisconsin industrial school for boys, for current expenses, including painting and necessary repairs, to January 1, 1884, forty thousand dollars (\$40,000); for current expenses, including painting and necessary repairs, to January 1, 1885, forty thousand dollars (\$40,000); for building root cellar and straw barn, fifteen hundred dollars (\$1,500); for purchase of one hundred and twelve and thirty-one hundredths (112 31/100) acres of land adjoining land now owned by the state, eight thousand and eight hundred dollars (\$8,800). To the Wisconsin institution for the education of the deaf and dumb, for current expenses, including painting and necessary repairs, to March 1, 1884, forty thousand dollars (\$40,000); for current expenses, including painting and necessary repairs, to March 1, 1885, forty thousand dollars (\$40,000); for providing protection against fire, fifteen hundred dollars (\$1,500). To the Wisconsin institution for the education of the blind, for current expenses, including painting and necessary repairs, to March 1, 1884, eighteen thousand dollars (\$18,000); for current expenses, including painting and necessary repairs, to March 1, 1885,

eighteen thousand dollars (\$18,000). To the Wisconsin state prison, for current expenses to March 1 1884, fifteen thousand dollars (\$15,000); for current expenses to March 1, 1885, fifteen thousand dollars (\$15,000); to build root cellar, one thousand dollars (\$1,000).

SECTION 2. No part of the money hereby appropriated for the purchase of real estate shall be drawn from the treasury until an abstract of the title thereto shall be furnished and submitted to the attorney general, and he shall certify that the state acquires, or will acquire by the proposed conveyance, a good title thereto, free and clear of all liens and incumbrances. And it is hereby made the duty of the attorney general to examine said abstracts of title, and proposed conveyances, and give his opinion thereon, as contemplated by the foregoing provisions.

SECTION 3. The sum of five thousand dollars (\$5,000) appropriated for providing efficient means for extinguishing fire and furnishing ordinary supply of water to the Wisconsin institution for the deaf and dumb by section 1 of chapter 33, laws of 1882, and which has not been expended by the state board of supervision for that purpose, is hereby covered into the state treasury.

SECTION 4. This act shall take effect and be in force from and after its passage and publication. Approved March 22, 1883.

#### CHAPTER 143.

AN ACT to authorize the towns of Clayton, Haney and Utica, or either of them, to build and maintain a bridge across the Kickapoo river at a point therein named.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. The towns of Clayton, Haney and Utica, in the county of Crawford, or either of them, are hereby authorized and empowered to construct and maintain, or cause to be constructed and maintained, a bridge across the Kickapoo river, at or near the town line, between township number nine (9) and township number ten (10), in said county of Crawford. May maintain  
a bridge.

SECTION 2. If the towns of Clayton, Haney and Utica, or either of them, fail to make a provision
