SECTION 2. This act shall take effect and be in force from and after its passage and publication.

NOTE BY THE SECRETARY OF STATE.—The foregoing act having been presented to the governor for his approval, and not having been returned by him to the house of the legislature, in which it originated, within the time prescribed by the constitution of the state, has become a law without his approval.

### CHAPTER 257.

AN ACT to amend chapter 181 of the revised statutes, entitled "of offenses against the lives and persons of individuals."

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Section 4387 of chapter 181 of the revised statutes of 1878, is hereby amended by striking out the words "not more than two years nor less than one year," and inserting in lieu thereof, "not more than five years nor less than one year," so that said section, when so amended, shall read as follows: Section 4387. Any person who shall, without lawful authority, forcibly or secretly confine or imprison another, within this state, against his will, or who shall forcibly carry or send another out of this state, or from place to place within this state, against his will and without lawful authority, or who shall, without such authority, forcibly seize, confine, inveigle or kidnap another, with intent to cause such person to be secretly confined or imprisoned in this state, against his will, or to be sent or carried out of this state, against his will, or to be sold as a slave, or in any way held to service, against his will, shall be punished by imprisonment in the state prison not more than five years nor less than one year, and such offense may be tried in the county where it is committed, or in any county into which the person so kidnapped may be carried or sent; and upon the trial thereof, the consent thereto of the persons so seized, confined, in-

veigled or kidnaped shall not be a defense, unless it shall be made satisfactorily to appear that such consent was not obtained by fraud, nor extorted or forced by duress or threats.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 258.

AN ACT to provide for the annual publication of a railroad map, and appropriating money therefor.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. There shall be published annually, under the supervision of the railroad commissioner, three thousand copies of the railroad map of Wisconsin, two thousand copies to be distributed with the annual report of the railroad commissioner, four hundred copies to be distributed by the state superintendent of public instruction among the schools of the state, and the remainder to be distributed by the railroad commissioner. There shall also be published thirty-five hundred copies of said map over and above the number hereinbefore provided for, for the use of the present legislature, and thirty-five hundred copies for each legislature biennially thereafter.

SECTION 2. There is hereby appropriated annually, out of the state treasury, a sum sufficient for the purposes in this act mentioned.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.
