

or Sons of Temperance, Grand Army of the Republic, or of the State Grange, or any subordinate grange of the order of Patrons of Husbandry, acting under the authority of a state or national grange, or of any other society constituted in a manner generally similar to either of the foregoing, may assemble at their usual place of meeting, and in pursuance of the rules of their society, elect not less than three nor more than nine of their number trustees to take care of the property, real and personal, belonging thereto, and transact all the business relative to the investment and disposal thereof.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 56.

AN ACT to appropriate to the Wisconsin State Horticultural society a sum of money therein named.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. There is hereby appropriated to the Wisconsin State Horticultural society the sum of one thousand dollars (\$1,000) out of any money in the state treasury not otherwise appropriated. This appropriation is made to cover the years of 1883 and 1884, and shall be paid to said society in two annual equal payments, viz: in 1883 and 1884. Appropriation.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 57.

AN ACT to legalize the acts of the executive committee of the school board of directors of the town of Antigo, Langlade county, and the several subdistrict clerks constituting said board of directors.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. The acts of the executive committee of the school board of directors of the town of Antigo, Langlade county, and the several subdistrict clerks constituting said board of directors, Acts legalized.

in the matter of holding over and continuing in office at the annual meeting of said board of directors, and at the several subdistrict annual elections for the year 1882, are hereby declared legal and valid, and the members of said executive committee and the said several subdistrict clerks are hereby declared the legal school officers of said town of Antigo for the school year of 1883.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

### CHAPTER 58.

AN ACT to appropriate a sum of money therein named for the purchase of stationery for the use of the state.

*The people of the state of Wisconsin, represented in senate and Assembly, do enact as follows:*

SECTION 1. There is hereby appropriated out of any money in the general fund, not otherwise appropriated, the sum of two thousand and five hundred dollars (\$2,500), for the purchase of stationery for the use of state officers and departments for the year 1883, and the sum of three thousand five hundred dollars (\$3,500), to purchase stationery for the use of state officers and departments for the year 1884 and for the legislative session of 1885. Said sums, being the amount estimated as necessary for the purpose named.

SECTION 2. The unexpended balance of appropriations heretofore made for the purchase of stationery, to-wit: The sum of twenty-five dollars and eighty-six cents (\$25.86), of the appropriation of 1881, and the sum of one thousand seven hundred and twenty-five dollars and twenty-four cents (1,725.24), of the appropriation of 1882 is hereby covered into the state treasury.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.
