

Tax to be levied annually.

SECTION 4. The common council of said city shall annually levy a tax sufficient to pay the interest upon all the out standing bonds, as the same shall become payable. All moneys received from the collection of such taxes or from the sale of such bonds, shall be strictly kept as a special fund and shall only be paid out for the purposes herein prescribed and for no other.

SECTION 5. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 122.

AN ACT amending the charter of the Evansville Seminary, and the several acts amendatory thereof.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Charter of Evansville Seminary amended.

SECTION 1. Chapter 133, session laws of 1880, is amended by striking out of the seventh, eighth and ninth lines of the aforesaid section the following words, to wit: "On the last Wednesday of November in each year at seven o'clock P. M.," and inserting instead thereof the following: "On Wednesday at seven o'clock P. M. on commencement day in June of each year hereafter," so that the aforesaid section 1, when amended shall read as follows: Section 1. The first section of chapter 272 of the private and local laws of the year 1870, amending the charter of the Evansville

Seminary, is hereby amended so as to read as follows: There shall be an annual meeting of the trustees of said seminary, held in the seminary building in the village of Evansville, Rock county, Wisconsin, on Wednesday at seven o'clock P. M., on commencement day in June of each year hereafter, to elect that class of trustees whose term of office shall then expire. Such elections shall be by ballot, and the persons equal to the number of trustees whose term of office then expires, receiving the highest number of votes, being not less than seven, shall be declared elected. Each and every trustee of said corporation shall be entitled to vote at such election.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 123.

AN ACT to amend section 371, of the revised statutes, concerning the purchase of books for the state library, and increasing the appropriation therefor.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Section 371, of the revised statutes, is hereby amended so as to read as follows: The trustees shall procure for the library, from time to time, such law books, books of reference and works on political science and statistics, but no others, as they shall think reasonably necessary or desirable. There is hereby appropriated for the purpose of paying for such books two thousand dollars per year. The accounts for such purchases shall be audited by the secretary of state upon affidavits by the state librarian that the books have been received in the library, and upon approval thereof by the trustees, or a majority of them.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
