## CHAPTER 395.

AN ACT concerning insurance companies, and to authorize insurance commissioner to sue for and collect penalties.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. It is hereby made the duty of the commissioner of insurance, to prosecute to final judgment, in the name of the state, or to compromise, settle, or compound every forfeiture incurred by any insurance corporation, by its failure to comply with, or for its violation of any law of the state, of which he may be credibly informed.

Insurance commissioner authorized to sue for and collect penalties.

SECTION 2. One-half of every sum collected, paid or received by virtue of section 1, of this act, shall be paid into the state treasury, and the remainder shall belong to the commissioner of insurance, who shall pay all expenses incurred in prosecuting all actions brought to enforce the payment of such forfeitures, both in and out of the state, and shall pay all expenses incident to the collection of such forfeitures.

Penalties collected—how disposed of.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 396.

AN ACT to repeal chapter 263, of the general laws of 1883, relating to the reversion of certain lands to the towns of Lawrence and Ashwaubenton, in Brown county, Wisconsin.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Section 2, of chapter 351, laws of 1883, entitled, "An act to incorporate the city of

Boundaries of Nicolet defined.

Nicollet," is hereby restored, so as to read as follows: All the territory within Brown county, hereinafter described and bounded, shall be included in and constitute the limits of the city of Nicollet, to wit: Commencing at a point where the center channel line of Ashwaubenon Creek (so called) intersects the center of the channel of Fox River; thence along the center of said creek, up stream through private claims twenty-five, twenty-six, twenty-seven, twenty-eight and twenty-nine, west side of Fox River, in the county of Brown, including the parts of said private claims lying between Ashwaubenon Creek on the west and the Fox River on the east; also fractional section twenty-one, township twenty-three, range twenty, and lot four, of fractional section twenty, town twenty-three, range twenty, and all that part of the northeast quarter of section twenty-nine, town twenty-three, range twenty, lying east of Ashwaubenon Creek, and all that part of section twenty-eight, town twenty-three, range twenty, lying north of the east and west quarter line of said section twenty-eight; also a tract of land about fifteen acres, owned by G. E. Armstrong and James Miller, being all of fractional section twenty-seven, west of Fox River, town twenty-three, range twenty, and lots four and five, in section twenty-eight, town twenty-three, range twenty, and lots one, two and three, all in section thirty-three, town twenty-three, range twenty; thence easterly from the south point of said lot three, to the center of the channel of Fox River; thence following said channel down stream to the place of beginning, shall constitute the limits and boundaries of the city of Nicollet.

Repealed.

SECTION 2. Chapter 263, of the general laws of 1883, entitled, "An act for the reversion of certain lands to the towns of Lawrence and Ashwaubenon in Brown county, Wisconsin, is hereby repealed.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.
