AN ACT to amend section 1249, of the revised statutes of 1878, relating to highways and bridges.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Amending sec. 1249, R. S. SECTION 1. Section 1249, of the revised statutes of 1878, is hereby amended by adding to the same after the word, "action," where it occurs in the last line and at the end of said section, the following words: "But the overseer of highways shall in all cases of removing a snow-drift or snow blockade, make such highway passable for at least four feet and ten inches (in) width, at the bottom of the track of said road."

SECTION 2. This act shall take effect and be in force from and after the passage and publication of this act.

CHAPTER 180.

AN ACT to amend section 1771, of the revised statutes, entitled, "of the organization of corporations."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Amending sec. 1771, R. S.

SECTION 1. Section 1771, of the revised statutes, entitled, "of the organization of corporations," is hereby amended by adding at the end of said section the following: The executors or trustees under any will, or one or more of such executors or trustees, who are authorized, requested or directed by the provisions of any will to organize a

corporation for any of the purposes mentioned in this section, or the general laws of this state, may, individually or as executors, or together with the legatees mentioned in the will, or one or more of such executors, trustees or legatees, may sign, execute, verify and acknowledge articles of incorporation or association under the provisions of chapter 85, of the revised statutes, for the purpose of carrying out the intentions of the testator as expressed in his will, and for the purpose of forming and organizing such corporation, and in such case may transfer and convey to such corporation any property of the testator mentioned and referred to in such will and authorized or required to be used for such purpose, and said executors, trustees or legatees, or two or more of them, may subscribe to the capital stock of such corporation to the amount of the value of the property mentioned and referred to in such will, and such executors or trustees may convey the property mentioned or referred to, to such corporation in payment of the stock so issued and subscribed without application to or authority from any court.

SECTION 2. This act shall take effect and be in force from and after its passage and publication. Approved March 31, 1867.
