## CHAPTER 20.

AN ACT to change the name of the Milwaukee Mechanics' Mutual Insurance company.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. The name of the Milwaukee Mechanics' Mutual Insurance company, a corporation created by and existing under chapter 43, of the acts of the legislature of 1852, and the several acts amendatory thereof, is hereby changed to "Milwaukee Mechanics' Insurance Company," by which name said corporation shall hereafter be known and designated in all courts and places.

Name of Milwaukee Mechanics, Mutual Insurance Company changed.

SECTION 2. This act shall take effect and be in force from and after the first day of April, A. D. 1887.

## CHAPTER 21.

AN ACT to repeal chapter 176, of the laws of 1879, and to abolish the board of immigration thereby established.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Chapter 176, of the laws of this state for the year 1879, entitled, "an act to establish a board of immigration," approved March 4th, 1879, is hereby repealed, and the board of immigration thereby created, is hereby abolished.

Abolishing Board of Immigration.

SECTION 2. The governor and secretary of state are hereby authorized and instructed, as soon as possible after the passage of this act, to settle and audit all accounts of the said board, and to pay

the same out of the balance in the state treasury heretofore appropriated to said board.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 22.

AN ACT to amend chapter 258, of the laws of 1883, entitled, an act to provide for the annual publication of a railroad map, and appropriating money therefor.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Annual publication of railroad map—how distributed—appropriation.

SECTION 1. Section 1, of chapter 258, of the laws of 1883, is hereby amended, so as to read as follows: There shall be published annually, under the supervision of the railroad commissioner, four thousand copies of the railroad map of Wisconsin; two thousand copies to be distributed with the annual report of the railroad commissioner, one thousand four hundred to be mounted on muslin and provided with rollers, to be distributed by the state superintendent of public instruction among the schools of the state, and the remainder to be distributed by the railroad commissioner. There shall also be published thirty-five hundred copies of said map, over and above the number herein before provided for, for the use of each legislature biennially hereafter.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
